A. Discussion: Increase in Extra-Duty Hourly Rate

The board stated that they wanted more information on the increase in extra-duty hourly rate email that was sent to them in December 2019. Johnathan was asked by the board if it was possible to provide them with more information on the increase.

B. Update: 2019-2020 After-School Program

Officer Feliciano provided an update to board on the after-school program. There are currently 35-37 students in the program, and everyone has been doing good. They have one same teacher from last year's program and the police officers are rotating, so sergeants, police officers and school-resource officers are the majority that attend the program. They are trying to implement a 'no cellphone use policy' for the first hour of the program. The board discussed wanting to schedule a parent conference in February, possibly the second week of February. Officer Feliciano will check and get back to them.

C. Update: Sponsorship Appreciation Event

The board discussed the possibility of having a joint sponsorship appreciation event with the Parks & Recreation Department, but they don't host their event until late May. The board decided to do their own sponsorship appreciation event, possibly in late March. Juanita will send the board an email with the City's available dates for March. More will be discussed at the next meeting.

D. Open Discussion

The board asked for an update on the Doral 5K amount, Erin informed them that she will possibly have the total amount by the next meeting date. Erin also informed the board that they are looking into changing the date from January to possibly February, March or April.

Director Canchola and Officer Feliciano discussed the mobile traffic park. She informed the board that their main target would be elementary schools. In regard to the supplies, Lieutenant Munecas was going to send the board an email on where they can buy the stop signs and traffic lights for the park. Also, the board was looking for more details on the trailer that was discussed at the November meeting but Director Horruitiner was not present at the meeting. More will be discussed at the next meeting.

- A. Director Steinbauer informed the board that the 'Cigar Aficionado' event that Mayor Bermudez mentioned at the November Meeting went well. They raised over \$3000 and they will possibly bring the check to present to the board at one of the upcoming meeting dates.
