## RESOLUTION No. 21-138

A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AUTHORIZING THE CITY MANAGER TO WORK WITH THE UNIVERSITY OF MIAMI MILLER SCHOOL OF MEDICINE AND THE CHILDREN'S HEALTH SERVICE TO STATION THE PEDIATRIC MOBILITY CLINIC AT THE DORAL POLICE AND COMMUNITY CENTER AT REGULAR INTERVALS OVER THE COURSE OF ONE (1) YEAR, AND TO PROVIDE BASIC SUPPORT SERVICES THEREFORE IN ORDER TO BRING PEDIATRIC HEALTH CARE SERVICES TO THE COMMUNITY'S IMPOVERISHED RESIDENTS; PROVIDING FOR IMPLEMENTATION; AND PROVIDING FOR AN EFFECTIVE DATE

**WHEREAS,** the Children's Health Fund is a national network dedicated to bringing healthcare to impoverished children; and

WHEREAS, the Children's Health Fund and the University of Miami Miller of School of Medicine ("UM MED") have partnered to complete that mission in the greater Miami area through a Pediatric Mobility Clinic; and

WHEREAS, the Pediatric Mobility Clinic is a vehicle unit that is fully equipped to handle pediatric patient needs, including without limitation, an examination room, laboratory and waiting room for parents and guardians; and

WHEREAS, the Pediatric Mobility Clinic brings such services as, without limitation, Comprehensive primary care, School Physicals (Medical/Sports), Immunizations, Management of acute and chronic illnesses, Laboratory testing, Prescriptions, Hearing and Vision screenings, HIV and STI screening, Mental Health Counseling, Social work services, Access to Legal services, Case management, Psychology services, Nutritional assessment, Weight monitoring, Referrals to subspecialty and dental care, and Telehealth; and

WHEREAS, UM MED works to bring the Pediatric Mobility Clinic to all community of Miami-Dade County and has expressed an interest to continue services in the City of Doral; and

**WHEREAS**, UM MED, the Children's Health Fund, and the City of Doral desire to collaborate to bring the Pediatric Mobility Clinic to Doral.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY
OF DORAL AS FOLLOWS:

<u>Section 1.</u> <u>Recitals.</u> The above recitals are confirmed, adopted, and incorporated herein and made part hereof by this reference.

Section 2. Authorization. The City Manager is hereby authorized to work with UM MED and the Children's Health Fund to station the Pediatric Mobility Clinic at or near the Police Training and Community Center facility at regular intervals over the course of one (1) year and to provide basic support services therefore, in order to bring pediatric health care services to the community's impoverished residents.

<u>Section 3.</u> <u>Implementation.</u> The City Manager and the City Attorney are hereby authorized to take such further action as may be necessary to implement the purpose and the provisions of this Resolution.

<u>Section 4.</u> <u>Effective Date.</u> This Resolution shall take effect immediately upon adoption.
