5. Approval of Minutes

a. Discussion: City of Doral Sexual Harassment Training

b. Discussion: Cultural Diversity and Sensitivity Training

Motion was made by Alejandra Moreno to request from City Council they fund a "Sexual Harassment & Cultural Sensitivity Training" in September for public at large to attend. The Motion was seconded by Ana Taina Shepard.

c. Discussion: Miami-Dade County to hold Women's Equality Event on August 18th

Alejandra Moreno inquired if City of Doral can have representation during Miami-Dade County event? This was open for discussion amongst Board members, but no decision was made.

Ana Taina Shepard **inquired as to whether** City Council can pass a motion to create a **"Women's Equality Day"** for City of Doral in October for the public to attend, which would include a Proclamation and sponsored Event, whereby reputable speakers will be invited, and refreshments served.

Per Alejandra Moreno, a Proclamation was done for "Women's Equality Day" already on August 26, 2015. According to Maggie Santos, Proclamations only run year by year and that depending on the success of an event, it can be budgeted. Usually Council members propose it to the Board, though Maggie Santos will inquire due process and to provide a couple of dates available for this event and confirm it can be done at Doral Police Substation.

Motion was made by Alejandra Moreno to request a new Proclamation for August 26th at the City Council meeting of August 8th. The Motion was seconded by Thelma Cela, Board Member. By consensus, motion passes unanimously.
