

RESOLUTION No. 13-53

A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA AUTHORIZING THE CITY MANAGER TO NEGOTIATE AND ENTER INTO AN AGREEMENT WITH GANNET FLEMING, INC. FOR THE PROVISION OF CONSTRUCTION ENGINEERING INSPECTION SERVICES FOR THE CONSTRUCTION AND INSTALLATION OF BUS SHELTERS AND CONCRETE BENCH PADS AS PART OF THE DORAL TROLLEY INFRASTRUCTURE PROGRAM IMPROVEMENTS IN AN AMOUNT NOT TO EXCEED \$24,039.50; RECOGNIZING THAT GANNET FLEMING, INC. IS A CITY OF DORAL PRE-QUALIFIED VENDOR; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, the City of Doral Public Works Department is seeking to secure construction engineering inspection (CEI) services for the Doral Trolley Infrastructure Program improvements planned for Route 3; and

WHEREAS, Staff respectfully requests that the City Council authorize the City Manager to negotiate and enter into an agreement with Gannet Fleming, Inc. for the provision of CEI services for the construction and installation of bus shelters and concrete bench pads as part of the Doral Trolley Infrastructure Program improvements in an amount not to exceed \$24,039.50; and

WHEREAS, Gannett Fleming, Inc. is one of ten engineering and architecture firms from N.W. 36th Street to N.W. 58th Street; and

NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AS FOLLOWS:

Section 1. The City Council hereby authorizes the City Manager to negotiate and enter into an agreement with Gannet Fleming, Inc. for the provision of CEI services for the construction and installation of bus shelters and concrete bench pads as part of the Doral Trolley Infrastructure Program improvements in an amount not to exceed \$24,039.50.

Section 2. The City Council further recognizes that Gannet Fleming, Inc. is a City of Doral pre-qualified vendor.

Section 3. This Resolution shall take effect immediately upon adoption.

The foregoing resolution was offered by Councilwoman Ruiz who moved its adoption. The motion was seconded by Councilwoman Fraga and upon being put to a vote, the vote was as follows:
