A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, APPROVING A SPECIAL EVENT PERMIT REQUESTED BY TOGETHER FOR THE DOMINICAN CULTURE ORG TO HOST THE "DOMINICAN FESTIVAL" AT DOWNTOWN DORAL PARK LOCATED AT 8395 NW 53 STREET, DORAL, FL 33166, ON SUNDAY, FEBRUARY 26, 2023, FROM 10:00 AM TO 6:00 PM; PROVIDING FOR IMPLEMENTATION; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS Together for The Dominican Culture ORG (the "Applicant") seeks approval from the City of Doral of a special event permit to host "Dominican Festival" at Downtown Doral Park; and

WHEREAS, staff recommends that the Mayor and City Council approve the proposed special event permit to host the "Dominican Festival" at Downtown Doral Park, Sunday, February 26, 2023, from 10:00 a.m. to 6:00 p.m.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AS FOLLOWS:

<u>Section 1.</u> Recitals. The foregoing recitals are confirmed, adopted, and incorporated herein and made as part hereof by this reference.

<u>Section 2.</u> Approval. The special event permit for the "Dominican Festival" at Downtown Doral Park is hereby approved subject to the following conditions:

- 1. The Applicant shall secure all necessary and required building, electrical, plumbing, or other permits, and shall immediately furnish proof of such permits upon request from the city.
- 2. The Applicant shall be required to have all inspections and approvals prior to the event date.
- Sanitary facilities shall be provided by the Applicant and shall be of the type and in a sufficient number as to meet the requirements established by the Building Department.

- 4. The Applicant is responsible for providing adequate security at the special event. The police department may require the Applicant to provide and pay for security personnel for crowd control and traffic direction purposes. The county fire rescue department may require the Applicant to provide and pay for fire watch personnel.
- 5. The Applicant shall comply with comments made by the City of Doral Police Department and pay all applicable fees no later than 14 days in advance of the event.
- The Applicant shall comply with comments made by the City of Doral Parks and Recreation Department and pay all applicable fees no later than 14 days in advance of the event.
- 7. The Applicant shall provide to the City of Doral an acceptable certificate of insurance naming the city as an additional insured four (4) weeks prior to the event date.
- 8. The Applicant shall provide copy of parking agreement(s) to the Planning and Zoning Department thirty (30) days prior to event start date.
- 9. The Applicant shall obtain approval from the State of Florida Division of Alcoholic Beverages and Tobacco for the sale of alcoholic beverages prior to event start date. Proof of approval shall be submitted to the Planning and Zoning Department no later than 10 days in advance of the event start date.

<u>Section 3.</u> <u>Effective Date.</u> This Resolution shall become effective immediately upon its adoption.
