The City of Doral authorizes the firm of Pevida Highway Designers, LLC to proceed with the provision of professional engineering services for the development of construction plans for the "Do Not Block the Box" signage and pavement markings at intersections throughout the City as identified in the Transportation Master Plan. The work should be performed in accordance with the contract provisions contained in the Continuing Professional Services Agreement between Pevida Highway Designers, LLC and the City of Doral dated February 16, 2018, and the attached Proposal submitted by your firm for the above referenced project.

SCOPE OF SERVICES AND SCEHDULE:

The scope of the project will be as described in the attached proposal dated May 7, 2018 from Pevida Highway Designers, LLC. The schedule requires the work to be performed within ninety (90) days from the date of execution. All limitations of time set forth in this Work Order are of the essence. The performance of services associated with this Work Order will be executed on a lump sum basis with a not to exceed amount of \$20,110.00.

You are required by the Continuing Service Agreement to begin work subsequent to the execution of this Work Order, or as directed otherwise. If you fail to begin work subsequent to the execution of this Work Order, the City of Doral will be entitled to disqualify the Proposal, and revoke the award.

Work Order incorporates the terms and conditions set forth in the Continuing Services Agreement dated February 16, 2018 between the parties as though fully set forth herein. In the event that any terms or conditions of this Work Order conflict with the Continuing Services Agreement, the provisions of this specific Work Order shall prevail and apply. This Work Order is not binding until the City of Doral agrees and approves this Work Order.

A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, APPROVING A WORK ORDER BETWEEN THE CITY OF DORAL AND PEVIDA HIGHWAY DESIGNERS, A PREQUALIFIED VENDOR, TO PROCEED WITH THE DESIGN SERVICES FOR "DO NOT BLOCK THE BOX" SIGNAGE AND PAVEMENT MARKINGS AT INTERSECTIONS WITHIN THE CITY IN AN AMOUNT NOT EXCEED \$20,110.00; AUTHORIZING THE CITY MANAGER TO EXECUTE THE WORK ORDER AND EXPEND BUDGETED FUNDS ON BEHALF OF THE CITY; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, the City of Doral's (the "City") Public Works Department ("Public Works") developed the Congestion Management Plan to implement strategies that would alleviate traffic congestion; and

WHEREAS, as a result of the Congestion Management Plan, the Traffic Relief Board was initiated to coordinate the implementation of the improvements identified in the Congestion Management Plan and is comprised of staff from Miami-Dade County, Doral Code Compliance, and the Doral Police Department ("Doral Police"); and

WHEREAS, a suggestion from Doral Police at the June 2016 Traffic Relief Board meeting was to include the "Do Not Block the Box" signing and pavement marking improvements to the assist with the signal re-timing that was already performed as part of the Congestion Management Plan short-term strategies; and

WHEREAS, the Public Works has coordinated with Miami-Dade County for the execution and approval of the interlocal agreement whereby the City would be able to implement these improvements; and

WHEREAS, the interlocal agreement with Miami-Dade County for the design, installation, and maintenance of the "Do Not Block the Box" signage and pavement markings was executed by the County on May 29, 2018; and

WHEREAS, Pevida Highway Designers. is a prequalified provider of professional engineering services selected in accordance with Consultant Competitive Negotiation Act (CCNA) requirements and approved by the City Council in November 2017; and

WHEREAS, Staff recommends that the City Council approve the Work Order with Pevida Highway Designers to proceed with the design services for "Do Not Block the Box" signage and pavement markings at intersections within the City; in an amount not to exceed \$20,110.00.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL
OF THE CITY OF DORAL, FLORIDA, AS FOLLOWS:

<u>Section 1.</u> Recitals. The above recitals are confirmed, adopted, and incorporated herein and made part hereof by this reference.

<u>Section 2.</u> <u>Approval.</u> The Work Order between the City of Doral and Pevida Highway Designers for the provision of design services for the "Do Not Block the Box" signage and pavement markings at intersections within the City, in an amount not to exceed \$20,110.00., attached hereto as Exhibit "A", which is incorporated herein and made a part hereof by this reference, is hereby approved.

Section 3. Authorization. The City Manager is authorized to execute the work order and expend budgeted funds on the behalf of the City for the design services described.
