PROJECT UNDERSTANDING

Kimley-Hom will provide these services for the roadway improvements project. The roadway improvements are shown on the construction plans developed by Kimley-Horn during the Design phase.

SCOPE OF SERVICES

The scope of services for the post design phase of the project will be completed by Kimley-Horn and Associates, Inc. (Kimley-Horn) as outlined below:



TASK 01 – RESIDENT PROJECT REPRESENTATIVE (RPR)

The duties of Kimley-Horn under this task shall be limited to:

- Certification of As Built plans to be in conformance with the design and contract documents. The as built plans shall be generated, signed and sealed by the Contractor's Surveyor. The CONTRACTOR shall be responsible for survey work required for establishing proper layout, elevations and grades as noted on the plans.

The RPR shall compile all required documentation and submit to the Client for project closeout.

TASK 02-THE CLIENT'S ADDITIONAL SERVICES

Upon your authorization, we will provide any additional services that may be required beyond those described in Task 01. These services may include but are not limited to such items as the following:

- Post Design Services
- Public Involvement
- Preparation of right-of-way acquisition sketches or descriptions
- Contamination assessment and related services
- Any work related to grants of easement or right of way acquisition
- Services not specifically included within "Scope of Services"

FEE AND BILLING

Kimley-Horn will accomplish the services outlined in Task 01 on a labor fee plus expense basis with estimated labor fee shown below. Labor fee will be billed on an hourly basis according to the standard hourly rate agreed between Kimley-Horn and the Client. Direct expenses, if required, will be billed at 1.15 of the cost. Expenses are in addition to the labor amount. Fees and expenses will be invoiced monthly based upon actual services performed and expenses incurred as of the invoice date. Billing will be due and payable within twenty-five (25) days of receipt of invoice.
