FIRST AMENDMENT TO WORK ORDER NO. 1 BETWEEN THE CITY OF DORAL, FLORIDA AND

KING ENGINEERING ASSOCIATES, INC.

This First Amendment to King Engineering Associates, Inc. Work Order No. 9 made and entered into this 10 day of January, 2019, by and between the City of Doral, Florida, a municipal corporation of the State of Florida ("City") and King Engineering Associates, Inc. ("Consultant") having its place of business at 8700 W. Flagler Street, Suite 180, Doral, FL 33174, for the provision of Professional Services to proceed with preparation of a stormwater drainage feasibility study for the H-5 Basin to evaluate the benefits of installing a positive outfall discharging into the NW 58th St. Canal.

WHEREAS, the City of Doral is presently engaged in an Outfall Feasibility Study for the H-5 Basin to evaluate the benefits of installing a positive outfall discharging into the NW 58th St. Canal.; and

WHEREAS, the City of Doral is presently contracted with King Engineering Associates, Inc. for the professional services for the Outfall Feasibility Study for the H-5 Basin; and an increase in hours to complete the study is needed to ensure the completion of the project; and

WHEREAS, the original cost for the professional services for the Outfall Feasibility Study for the H-5 Basin approved by the Work Order was a not to exceed amount of \$24,993.00; and

WHEREAS, due to comments received by Miami-Dade County Department of Regulatory and Economic, hours for the professional service associated with the Outfall Feasibility Study for the H-5 Basin increased; and

WHEREAS, the cost for the provision of professional services was increased to a not exceed amount of \$36,890.20, with the cost of the amended work to be a not to exceed amount of \$11,897.00; and

WHEREAS, King Engineering Associates, Inc. is a prequalified provider of professional engineering services selected in accordance with Consultant Competitive Negotiation Act (CCNA) requirements and approved by the City Council in December 2014.

NOW THEREFORE, in consideration of the mutual covenants set forth in this First Amendment, the parties agree as follows:

Section 1. Recitals. The above recitals are true and correct and incorporated herein.

Section 2. Amendments. The following Sections of the Work Order are hereby amended to read as follows:

"SCOPE OF SERVICES AND SCHEDULE:

...The performance of services associated with this Work Order will be executed on a time and material basis with a not to exceed amount of \$24,993.00 \$36,890.20."

EXCEPT AS PROVIDED HEREIN, all other terms and conditions of the Contract dated February 9, 2015, remain in full force and effect.

A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AUTHORIZING THE CITY MANAGER TO EXECUTE THE FIRST AMENDMENT TO WORK ORDER NO. 9 BETWEEN KING ENGINEERING ASSOCIATES, INC. AND THE CITY OF DORAL, TO PROVIDE ADDITIONAL ANALYSIS FOR THE STORMWATER OUTFALL FEASIBILITY STUDY TO SERVE DRAINAGE AREAS ALONG SUB BASIN H-8, SUB BASIN H-5, AND NW 79 AVE IN AN AMOUNT OF \$11,897.00 FOR A TOTAL NOT TO EXCEED AMOUNT OF \$36,890.20; AUTHORIZING THE CITY MANAGER TO EXECUTE THE WORK ORDER AMENDMENT AND EXPEND BUDGETED FUNDS ON BEHALF OF THE CITY; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, the installation of a positive outfall discharging into the NW 58th St. Canal will reduce persistent drainage problems and flooding within Sub Basin H-8, Sub Basin H-5, and NW 79 Ave.; and

WHEREAS, via Resolution 18-15, the City of Doral Public Works Department (PWD) secured King Engineering Associates, Inc (King) to develop an Outfall Feasibility Study to serve the drainage areas along Sub Basin H-8, Sub Basin H-5, and NW 79 Ave.; and

WHEREAS, on October 18, 2018, King submitted to Miami-Dade County
Department of Regulatory and Economic (DRER) the initial findings of the Outfall
Feasibility Study for review; and

WHEREAS, DRER advised King that they must provide further information based off their initial findings and perform additional analyses to further review the Outfall Feasibility Study; and

WHEREAS, to continue the progress of the Outfall Feasibility Study to meet the requirements of DRER, King prepared a supplemental proposal on a time and material basis with a not to exceed amount of \$11,897.00; and

WHEREAS, City staff respectfully requests that the City Council approve the Amendment to Work Order No. 9 for King Engineering, a copy of which is attached hereto as Exhibit "A", for the provision of an Outfall Feasibility Study to serve the drainage areas along Sub Basin H-8, Sub Basin H-5, and NW 79 Ave. for a revised total not to exceed amount of \$36,890.20.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DORAL AS FOLLOWS:

<u>Section 1.</u> Recitals. The above recitals are confirmed, adopted, and incorporated herein and made part hereof by this reference.

Section 2. Approval. The Amendment to Work Order No. 9 between the City of Doral and King Engineering Associates, Inc for the provision of additional analysis for the Outfall Feasibility Study for the drainage areas along Sub Basin H-8, Sub Basin H-5, and NW 79 Avenue, in an amount not to exceed \$11,897.00 for a revised total not to exceed amount of \$36,890.20, a copy which is attached hereto as Exhibit "A", is hereby approved.

<u>Section 3. Authorization.</u> The City Manager is authorized to execute the work order amendment and expend budgeted funds on the behalf of the City.

<u>Section 4.</u> <u>Implementation.</u> The City Manager and the City Attorney are hereby authorized to take such further action as may be necessary to implement the purpose and the provisions of this Resolution.

<u>Section 5.</u> <u>Effective Date.</u> This Resolution shall take effect immediately upon adoption.
