A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, APPROVING A SPECIAL EVENT PERMIT REQUESTED BY RICKY RUSSIAN ON BEHALF OF RAYITO DE LUZ FUNDACION, TO HOST THE "NADANDO TODO POR UN NIÑO ESPECIAL" TO BE HELD AT LEGACY PARK LOCATED AT 11400 NW 82 STREET, DORAL, FLORIDA, 33178 ON SATURDAY, OCTOBER 8, 2022 FROM 8:00 AM TO 6:00 PM; PROVIDING FOR IMPLEMENTATION; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, Ricky Russian on behalf of Rayito De Luz Corp. (the "Applicant"), a notfor profit 501(c)(3) company seeks approval from the City of Doral for a special event permit to host the "Nadando Todo por Un Niño Especial" to be held at Doral Legacy Park; and

WHEREAS, the Applicant has requested that the City co-sponsor the event and contribute a total of \$5,000 which are the projected costs, funds allocated in the General Government- Other Current Charges account 001.50005.500490; and

WHEREAS, staff recommends that the Mayor & City Council approve the proposed special event permit to host the "Nadando Todo por Un Niño Especial" on Saturday, October 8, 2022 from 8:00 a.m. to 6:00 p.m.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AS FOLLOWS:

<u>Section 1.</u> Recitals. The foregoing recitals are confirmed, adopted, and incorporated herein and made as part hereof by this reference

Section 2. Approval. The Mayor and City Council hereby direct the City Manager and City Attorney to draft a sponsorship agreement between the City of Doral and Applicant in accordance with the City's Code of Ordinances. The special event permit for the "Nadando Todo por Un Niño Especial" at Doral Legacy Park is hereby approved subject to

the following conditions:

- 1. The Applicant shall secure all necessary and required building, electrical, plumbing, or other permits, and shall immediately furnish proof of such permits upon request from the city.
- 2. The Applicant shall be required to have all inspections and approvals prior to the event date.
- Sanitary facilities shall be provided by the Applicant and shall be of the type and in a sufficient number as to meet the requirements established by the Building Department.
- 4. The Applicant is responsible for providing adequate security at the special event. The police department may require the Applicant to provide and pay for security personnel for crowd control and traffic direction purposes. The county fire rescue department may require the Applicant to provide and pay for fire watch personnel.
- 5. The Applicant shall comply with comments made by the City of Doral Police Department and pay all applicable fees no later than 14 days in advance of the event.
- 6. The Applicant shall comply with comments made by the City of Doral Parks and Recreation Department and pay all applicable fees no later than 14 days in advance of the event.
- 7. The Applicant shall provide to the City of Doral an acceptable certificate of insurance naming the city as an additional insured four (4) weeks prior to the event date.

<u>Section 3.</u> <u>Effective Date.</u> This Resolution shall become effective immediately upon its adoption.
