A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AUTHORIZING THE APPLICATION TO THE EDWARD BYRNE MEMORIAL JUSTICE ASSISTANCE GRANT (JAG) PROGRAM FOR GRANT FUNDS IN THE AMOUNT OF \$71,000.00; AND AUTHORIZING THE CITY MANAGER TO EXPEND FUNDS IN THE AMOUNT NOT TO EXCEED \$71,000.00, FOR THE PURCHASE OF MODULAR VEHICLE BARRIERS AND A UTILITY TERRAIN VEHICLE; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, the City of Doral Police Department has been awarded \$71,000.00 from the Edward Byrne Justice Assistance Grant (JAG) Program as a reimbursable grant and expend funds from the Department of Justice—Byrne Grant Capital Outlay account (001.60005.500642) in an amount not to exceed \$71,000.00, which will be used to purchase modular vehicle barriers and utility terrain vehicle to increase public safety; and

WHEREAS, Staff respectfully requests that the Mayor and City Council authorize the application to the JAGC Program for grant funds in the amount of \$71,000.00 as a reimbursable grant and expend funds from the Department of Justice-Byrne Grant Capital Outlay account (001.60005.500642) in an amount not to exceed \$71,000.00 to purchase modular vehicle barriers and utility terrain vehicle to increase public safety.
