A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, APPROVING A WORK ORDER BETWEEN THE CITY OF DORAL AND GANNETT FLEMING, INC., FOR PROFESSIONAL ENVIRONMENTAL ENGINEERING SERVICES IN THE DEVELOPMENT OF ACTION ITEMS FROM THE CLIMATE ACTION PLAN (CAP) FOR A CITYWIDE OPERATIONS GREENHOUSE GAS (GHG) REDUCTION PLAN IN AN AMOUNT NOT EXCEED \$20,000.00; RECOGNIZING THAT GANNETT FLEMING, INC., IS A CITY OF DORAL PRE-QUALIFIED VENDOR; AUTHORIZING THE CITY MANAGER TO EXECUTE THE WORK ORDER AND EXPEND BUDGETED FUNDS ON BEHALF OF THE CITY; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, in 2016, the Green Element was updated as part of the City's Doral Comprehensive Plan Update to provide purpose and guidance in adopting and incorporating practices that help reduce GHG emissions and increase climate protection; and

WHEREAS, the City of Doral desires to establish measures, verify, and report (Data Management) all green programs to provide progress reports that verify effectiveness and quantify results; and

WHEREAS, Gannett Fleming, Inc., is a prequalified provider of professional environmental engineering services selected in accordance with Consultant Competitive Negotiation Act (CCNA) requirements and approved by the City Council in November 2017; and

WHEREAS, Staff respectfully requests that the Mayor and City Council members approve the Work Order with Gannett Fleming, Inc., to proceed with the development of action items identified from the CAP for a Citywide GHG reduction plan; in an amount not to exceed \$20,000.00.
