

**RESOLUTION No. 23-148**

**A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, ACCEPTING A GENERAL PROGRAM SUPPORT GRANT AWARD IN THE AMOUNT OF \$22,588.00, FOR THE CITY OF DORAL CULTURAL ARTS PROGRAM FROM THE STATE OF FLORIDA DIVISION OF ARTS AND CULTURE; AUTHORIZING THE EXPENDITURE OF MATCHING GRANT FUNDS AS REQUIRED THROUGH THE GRANT PROGRAM IN THE AMOUNT OF \$22,588.00; AUTHORIZING THE CITY MANAGER TO EXECUTE THE GRANT AGREEMENT WITH THE STATE OF FLORIDA; PROVIDING FOR IMPLEMENTATION; AND PROVIDING FOR AN EFFECTIVE DATE**

**WHEREAS**, in May of 2022, the City of Doral (“City”) Parks & Recreation Department (the “Department”) submitted a General Program Support grant application for the City’s Cultural Arts Programs, which grant is administered through the State of Florida Division of Arts and Culture; and

**WHEREAS**, the grant award will allow the Department to continue to provide multidisciplinary arts and cultural performances, visual arts exhibitions, and arts education programming at low-to no cost to the community; and

**WHEREAS**, the grant award will also allow the Department to expand offerings at the new Cultural Arts Center; and

**WHEREAS**, in August of 2023, the Department was notified that the grant application submitted was awarded and funded for the July 1, 2023 - June 30, 2024 grant program cycle; and

**WHEREAS**, the City Manager’s Office respectfully requests approval and authorization from the City Council to accept the General Program Support grant in the amount of \$22,588.00 for the City’s Cultural Arts Program, and to authorize the City Manager to execute a grant agreement with the State of Florida Division of Arts and Culture, and to expend matching grant funds as required by the grant program in the

amount of \$22,588.00. Funding is available in the 001.90005.500494- other current charges- Cultural Events for FY 22-23.

**NOW THEREFORE, BE IT RESOLVED BY THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AS FOLLOWS:**

**Section 1. Recitals.** The above recitals are confirmed, adopted, and incorporated herein and made a part hereof by this reference.

**Section 2. Approval & Authorization.** The Mayor and City Councilmembers hereby approve and accept the General Program Support grant by the State of Florida Division of Arts and Culture for the City's Cultural Arts Program in the amount of \$22,588.00. The City Manager is hereby authorized to execute a grant agreement with the State of Florida Division of Arts and Culture, provided the same is first approved as to form and legal sufficiency by the City Attorney, and to expend matching grant funds as required by the grant program in the amount of \$22,588.00.

**Section 3. Implementation.** The City Manager and the City Attorney are hereby authorized to take such action as may be necessary to implement the provisions of this Resolution.

**Section 4. Effective Date.** This resolution shall take effect immediately upon adoption.


