

RESOLUTION No. 24-43

A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, PURSUANT TO SECTION 2-321 OF THE CITY'S CODE OF ORDINANCES, AUTHORIZING THE CITY MANAGER TO PURCHASE AN ANNUAL LICENSE AND SUPPORT MAINTENANCE FOR THE VIGILANT LICENSE PLATE READER (LPR) CAMERAS IN AN AMOUNT NOT TO EXCEED \$53,508.00; AUTHORIZING THE CITY MANAGER TO EXPEND BUDGETED FUNDS; PROVIDING FOR IMPLEMENTATION; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, In March 2018, the City Council approved Resolution 18-40 to approve the purchase of annual licenses and support maintenance for the Vigilant License Plate reader cameras; and

WHEREAS, the maintenance of the LPR cameras is critical to their functionality as cameras are outdoors and subject to harsh weather conditions; and

WHEREAS, Vigilant is the sole provider of this service as it pertains to the hardware that is solely owned by this provider. The maintenance and Support invoice renews the Enterprise Service Maintenance contract required to continue operating the License Plate Reader cameras; and

WHEREAS, section 2-321 of the City Code of Ordinances (the "Code") provides that the City may waive the competitive bidding procedures, with City Council approval, upon the recommendation of the City Manager that it is in the best interest to do so, to obtain goods and services which cannot be acquired through the normal purchasing process due to insufficient time, the nature of the goods or services or other factors; and

WHEREAS, the City Manager has recommended the City Council wave the competitive bid process for the purchase contemplated herein because it is in the best interest of the City given the nature of the LPR cameras; and

WHEREAS, the City Manager recommends approving the Resolution authorizing the City Manager to purchase annual maintenance and support for the Vigilant License Plate Reader (LPR) Cameras in an amount not to exceed \$53,508.00. Funds are allocated in the IT Maintenance and Repair account 001.22005.500460.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AS FOLLOWS:

Section 1. Recitals. The above recitals are confirmed, adopted, and incorporated herein and made a part hereof by this reference.

Section 2. Approval. Pursuant to section 2-321 of the City Code, and upon the written recommendation of the City Manager, the Renewal of the annual license and support maintenance for the Vigilant LPR cameras is hereby approved.

Section 3. Authorization. The City Manager is hereby authorized to enter into an agreement, subject to approval as to form and legal sufficiency by the City Attorney, as may be necessary to procure the licenses and services contemplated herein, and to expend funds in furtherance hereof.

Section 4. Implementation. The City Manager and City Attorney are hereby authorized to take such further action as may be necessary to implement the purpose and provisions of this Resolution.

Section 5. Effective Date. This Resolution shall take effect immediately upon adoption.

The foregoing Resolution was offered by Vice Mayor Puig-Corve who moved its adoption.
