A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, PURSUANT TO SECTION 2-322 OF THE CITY CODE OF ORDINANCES, APPROVING THE AGREEMENT WITH WOLFBERG ALVAREZ AND PARTNERS FOR DESIGN SERVICES FOR THE EMERGENCY OPERATIONS CENTER (EOC); AUTHORIZING THE CITY MANAGER TO EXPEND BUDGETED FUNDS ON BEHALF OF THE CITY IN AN AMOUNT NOT TO EXCEED \$26,590.00; PROVIDING FOR IMPLEMENTATION; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, the City of Doral established the Office of Emergency Management (OEM) in 2014 as part of its commitment to prepare, respond, recover and mitigate any major disaster, whether natural or man-made. The City has operated as a Satellite Emergency Operations Center (EOC) while consistently expanding its capabilities in all stages of emergency management during incidents that can significantly impact the lives of Doral residents and business owners; and

WHEREAS, making the City of Doral a Divisional EOC will allow the City to have a representative at the Miami-Dade County EOC, which will expedite direct communication and request for resources. A Divisional EOC will also allow the City of Doral to have different Jurisdictions and Agencies representative such as FP&L, AT&T, Red Cross, Miami-Dade Police and Fire Department, FEMA, FBI, Homeland Security, etc.; and

WHEREAS, in order to accomplish the aforementioned objective, it is necessary to allocate the proper funding to design, equip and construct the technology infrastructure required for a sustainable, efficient, and interoperable City of Doral Divisional Emergency Operations Center; and

WHEREAS, the City has complied with statutorily mandated statutes requiring competitive bidding; and

WHEREAS the EOC serves as the coordination hub for an incident response.

The EOC will provide a central intelligence area for the City and a response team

personnel to gather critical information, coordinate response activities, and manage

personnel during emergencies and catastrophic events; and

WHEREAS, to accomplish the aforementioned objective, it is necessary to allocate the proper funding to design, equip and construct the technology infrastructure required for a sustainable, efficient, and interoperable City of Doral Divisional Emergency Operations Center; and

WHEREAS, the City Manager and the Police Department respectfully request authorization from the Mayor and City Council to enter into an agreement with Wolfberg Alvarez and Partners for the design of the Emergency Operations Center in the existing Police Department Headquarters located at 6100 N.W. 99th Avenue Doral, Florida for an amount not to exceed \$26,590.00.

NOW THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AS FOLLOWS:

<u>Section 1.</u> Recitals. The above recitals are confirmed, adopted, and incorporated herein and made part hereof by this reference.

Section 2. Approval. The agreement with Wolberg Alvarez and Partners for the design of the Emergency Operations Center (EOC) in an amount not to \$26,590.00.

<u>Section 3.</u> <u>Authorization.</u> The City Council hereby approves an agreement with Wolberg Alvarez and Partners for the design of the Emergency Operations Center

(EOC). Funding for this service is available in Account No. 001.60005.500650.
