Discussion Items

- During the meeting, Natalie French provided a comprehensive overview of the city's emergency management plans, outlining specific strategies and protocols for responding to hurricane season.
- Public Works has informed the board of an update on the status of the public lighting infrastructure at the upcoming meeting.
- During our meeting, the board discussed the benefit of announcing events such as "Coffee with a Cop" at least one week in advance. Additionally, Vice Chair Andy Abbate graciously offered to assist in planning and organizing these events.

- During the next meeting, a new secretary will be chosen to replace the current secretary who cannot continue in that role.
- The Miami-Dade Police Department (MDPD) has been offering the public complimentary gun safety awareness classes. As part of this program, the Doral Police Department (Doral PD) is currently exploring the possibility of implementing a similar initiative to provide Doral residents with access to similar educational opportunities related to gun safety.
- An initiative to edit the emergency management communication system using text
 messaging, phone calls, and emails has been proposed to display the police
 department on residents' caller IDs. This campaign aims to facilitate communication
 and dissemination of vital information during emergencies by harnessing the
 widespread use and convenience of text messaging.
- Improved traffic management measures and infrastructure upgrades have effectively resolved the traffic problems at the 58th and 102nd Ave intersections.
- The NIBRS report for April shows a notable decrease in various types of crime within the city. This positive trend indicates an overall improvement in the safety and security of our community.
- The board has requested a presentation of a charter for emergency management to the council.
- There is a curfew for kids during the summer, and a social media campaign will be launched to spread awareness. Curfew violations will be enforced. Officers have been informed about potential summer daytime behavioral deviations.
- Nine of the 16 new vehicles have been equipped and prepared. At the next meeting, updates on the remaining vehicles will be provided.
- Ginger's active participation in the summer session has been verified, indicating her engagement in the activities and events scheduled during this period.
