FIRST AMENDMENT TO WORK ORDER NO. 09 BETWEEN THE CITY OF DORAL, FLORIDA AND BCC ENGINEERING, INC.

This First Amendment to BCC Engineering, Inc. Work Order No. 09 made and entered into this 12 day of June, 2020, by and between the City of Doral, Florida, a municipal corporation of the State of Florida ("City") and BCC Engineering, Inc. ("Consultant") having its place of business at 6401 SW 87th Avenue, Miami, FL, 33143, for the provision of to provide Construction Engineering & Inspection (CEI) services for the construction of a new traffic signals along NW 74 Street at NW 97 Avenue and NW 102 Avenue.

WHEREAS, the City of Doral is presently engaged in the construction of new Traffic Signals at the intersections of NW 97th and 102nd Avenue on NW 74th Street; and

WHEREAS, the awarded Construction Engineering Inspection (CEI) firm's budget was exhausted prior to project completion as a result of revised NTP due to permitting and material delays; and

WHEREAS, the City of Doral is presently contracted with BCC Engineering, Inc. to provide Construction Engineering Inspection (CEI) services throughout the duration of the construction schedule; and

WHEREAS, due to the extended construction completion date additional hours are required to ensure that CEI services will be conducted up to project closeout; and

WHEREAS, the original cost for the CEI Services approved by the Work Order was a not to exceed amount of \$95,264.80; and

WHEREAS, the cost for the provision of CEI services was increased to a not exceed amount of \$123,307.30 for the additional hours required to provide coverage up to project closeout, with the cost of the amended work to be a not to exceed amount of \$28,042.50; and

NOW THEREFORE, in consideration of the mutual covenants set forth in this First Amendment, the parties agree as follows:

Section 1. Recitals. The above recitals are true and correct and incorporated herein.

Section 2. Amendments. The following Sections of the Work Order are hereby amended to read as follows:

"SCOPE OF SERVICES AND SCHEDULE:

...The performance of services associated with this Work Order will be executed on a time and material basis with a not to exceed amount of \$95,264.80\$123,307.30."

EXCEPT AS PROVIDED HEREIN, all other terms and conditions of the Contract dated February 5, 2018, remain in full force and effect.

RESOLUTION No. 20-143

A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AUTHORIZING THE CITY MANAGER TO EXECUTE THE FIRST AMENDMENT TO WORK ORDER No. 9 WITH BCC ENGINEERING, INC. TO INCREASE THE AVAILABLE FUNDS FOR PROFESSIONAL SERVICES TO COVER THE COST OF ADDITIONAL CONSTRUCTION ENGINEERING AND INSPECTION (CEI) SERVICES AND PROJECT CLOSURE FOR THE NEW TRAFFIC SIGNALS ALONG NW 74 STREET AT NW 97 AVENUE AND AT NW 102 AVENUE IN AN AMOUNT NOT TO EXCEED \$28,042.50; AUTHORIZING THE CITY MANAGER TO EXECUTE THE AMENDMENT AND EXPEND BUDGETED FUNDS ON BEHALF OF THE CITY; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, via Resolution 19-147, the design of the New Traffic Signals along NW 74th Street at NW 97th Avenue and at NW 102nd Avenue was awarded to BCC Engineering, Inc. (BCC); and

WHEREAS, the improvements include the construction of traffic signals and roadway improvements along NW 74th Street at NW 97th Avenue and at NW 102nd Avenue to include new traffic signals, sidewalks, curb and gutter, and other roadway improvements.; and

WHEREAS, on June 12, 2019 the City executed Work Order No. 9 (as part of RFQ 2017-21, Pool of Pre-Qualified Engineering and Architecture Firms) for BCC to provide Construction Engineering & Inspection (CEI) and Post Design services for the construction of traffic signals and roadway improvements along NW 74th Street at NW 97th Avenue and at NW 102nd Avenue in a not to exceed amount of \$95,264.80, as approved by Resolution No. 19-147; and

WHEREAS, BCC's proposal considered services for the anticipated 6-month project duration; and

WHEREAS, the construction phase of the Project was advertised on April 23, 2019 and awarded for construction to Continental Construction, Inc. via Resolution No. 19-145, in a not to exceed amount of \$937,591.05 (which included a 10% contingency for any unforeseen conditions); and

WHEREAS, the "Original" construction Notice to Proceed was issued on October 14, 2019 and considered a Project Contract duration of 180 calendar days which set an "Original" completion date of April 11, 2020; and

WHEREAS, the Notice to Proceed (NTP) date was amended on February 28, 2020 as a result of Miami-Dade County's Construction / MOT permit delays; and

WHEREAS, a revised NTP was issued for March 9, 2020 which set a new completion date of September 5, 2020; a 180 calendar day project duration period; and

WHEREAS, funding was expended during the original NTP date of October 14, 2019 thru the new revised NTP date of March 9, 2020, as a result of the Project's precommencement coordination with utilities and to address all the comments, changes, and requests provided by Miami-Dade County during their Construction / MOT Permit phase.

WHEREAS, the additional unforeseen efforts depleted a portion of the available CEI funding as the hours considered had to be used for "Engineering" purposes; and

WHEREAS, in an interim basis, as a result of PWD diminished workload (COVID-19 related), the PWD inspectors have performed random inspections to

compensate suspension of service issued to BCC; compensating for its depleted funds; and

WHEREAS, currently, BCC has funding available for close-out documentation and certification of project only; and

WHEREAS, currently, the PWD's workload has increased; exposing this project to proper oversight; and

WHEREAS, in order to resume the day-to-day inspections of construction, ensuring that the improvements are constructed consistent with the approved plans and allow for a proper closeout of the project, the PWD requested a proposal from BCC to extend the CEI services until the completion of the project.; and

WHEREAS, PWD staff and BCC negotiated the attached supplemental proposal on a time and material basis with a not to exceed amount of \$28,042.50; and

WHEREAS, City staff respectfully requests that the City Council approve the Amendment to Work Order No. 9 for BCC Engineering, Inc, a copy of which is attached hereto as Exhibit "A", for additional hours of CEI services and professional services for the New Traffic Signals Along NW 74th Street at NW 97th Avenue and at NW 102nd Avenue; and

WHEREAS, funding for this request is available in the Public Works Department Fiscal Year 2019-20 Transportation Fund, Account Num. 101.80005.500650.
