A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, APPROVING A WORK ORDER BETWEEN THE CITY OF DORAL AND MARLIN ENGINEERING, A PREQUALIFIED VENDOR, FOR THE PROVISION OF CONSTRUCTION ENGINEERING INSPECTION SERVICES FOR THE NW 92 AVENUE ROADWAY CONSTRUCTION PROJECT BETWEEN NW 27 STREET AND NW 33 STREET IN AN AMOUNT NOT TO EXCEED \$119,511.20; AUTHORIZING THE CITY MANAGER TO EXECUTE THE WORK ORDER AND EXPEND BUDGETED FUNDS ON BEHALF OF THE CITY; PROVIDING FOR IMPLEMENTATION; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, the City of Doral (the "City"), by and through its Public Works Department, wishes to secure a firm to provide Construction Engineering Inspection services ("CEI Services") for the construction of roadway improvements on NW 92 Avenue between NW 27 Street and NW 33 Street ("Project"); and

WHEREAS, Marlin Engineering is a pre-qualified provider of professional engineering services selected in accordance with Consultant Competitive Negotiation Act requirements and approved by the City Council in December 2014; and

WHEREAS, City has recommended that the City Council approve Work Order No. 4 with Marlin Engineering, a copy of which is attached hereto as Exhibit "A", which is incorporated herein and made part hereof by this reference, for the provision of CEI services on the construction of the Project in an amount not to exceed \$119,511.00.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL
OF THE CITY OF DORAL, FLORIDA, AS FOLLOWS:

Section 1. Recitals. The above recitals are confirmed, adopted, and incorporated herein and made part hereof by this reference.
