A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AUTHORIZING THE CITY MANAGER TO EXTEND THE EXISTING AGREEMENT WITH FOURTY LOVE INC. FOR THE PROVISION OF PROVIDING INSTRUCTIONAL TENNIS PROGRAMMING SERVICES FOR CITY OF DORAL PARKS AND RECREATION DEPARTMENT FOR A PERIOD OF THREE (3) MONTHS **PROVIDING** THROUGH SEPTEMBER 2018; IMPLEMENTATION: AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, the City of Doral (the "City") has an existing agreement with Fourty Love Inc. for instructional tennis programming services at Morgan Levy Park; and

WHEREAS, Request for Proposal #2018-15, "Morgan Levy Park Instructional Tennis Programming" (the "RFP") is currently advertised for the provision of providing instructional tennis programming services at Morgan Levy Park; and

WHEREAS, staff recommends the City Council authorize the City Manager to extend the agreement with Fourty Love Inc. for the provision of providing instructional tennis programming services at Morgan Levy Park for the City of Doral Parks and Recreation Department for a period of three (3) months through September 2018 while submittals for RFP #2018-15 "Morgan Levy Park Instructional Tennis Programming" are received, scored, and recommended to Council.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AS FOLLOWS:

<u>Section 1.</u> <u>Recitals.</u> The above recitals are confirmed, adopted, and incorporated herein and made a part hereof by this reference.

<u>Section 2.</u> <u>Approval of Extension</u>. The City Manager is hereby authorized to extend the agreement with Fourty Love Inc. for the provision of providing instructional

tennis programming services at Morgan Levy Park for the City of Doral Parks and Recreation Department for a period of three (3) months through September 2018.

<u>Section 3.</u> <u>Implementation.</u> The City Manager and the City Attorney are hereby authorized to take such action as may be necessary to implement the provisions of this Resolution.

<u>Section 4.</u> <u>Effective Date.</u> This resolution shall take effect immediately upon adoption.
