SECOND AMENDMENT TO PROFESSIONAL SERVICES AGREEMENT

This Second Amendment ("Amendment") is dated effective this day of _______, 2022 (the "Effective Date") and is entered into between American Traffic Solutions, Inc., doing business as Verra Mobility ("Verra Mobility"), a Kansas corporation duly registered under the laws of the State of Florida to do business in Florida, with its principal place of business at 1150 N. Alma School Road, Mesa, Arizona 85201, and the City of Doral, Florida ("Customer" or "City"), a municipal corporation of the State of Florida (each individually a "Party" and collectively the "Parties").

RECITALS

WHEREAS, on June 20, 2017, the Customer and Verra Mobility entered into a Professional Services Agreement ("Original Agreement"), which was amended on June 3, 2019 ("First Amendment") (with the Original Agreement as amended by the First Amendment collectively referred to herein as the "Agreement"); and

WHEREAS, Section 16. of the Agreement provides the Parties may extend terms or modify conditions, including scope of services, of the Agreement by duly executed written amendments; and

WHEREAS, the Parties desire to extend the term of the Agreement and modify certain conditions, including the scope of services and fees for said services, in the Agreement.

TERMS AND CONDITIONS

NOW THEREFORE, the Customer and Verra Mobility hereby agree as set forth below:

- 1. **Term.** Consistent with the Original Agreement entered into on June 20, 2017, as amended by the First Amendment, the term of this Agreement is extended through June 20, 2023. All other terms and conditions of the Agreement shall remain the same and unchanged.
- 2. The provisions of the Agreement, as amended by this Amendment, including the recitals, comprise all of the terms, conditions, agreements, and representations of the Parties with respect to the subject matter hereof. Except as expressly amended or modified by the terms of this Amendment, all terms of the Agreement shall remain in full force and effect. In the event of a conflict between the terms of this Amendment and the Agreement, the terms of this Amendment shall prevail and control.
- 3. This Amendment may be executed in one or more counterparts, each of which shall constitute an original, but all of which taken together shall constitute one and the same instrument. Each Party represents and warrants that the representative signing this Amendment on its behalf has all right and authority to bind and commit that Party to the terms and conditions of this Amendment.
