## RESOLUTION No. 17-164

A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, PURSUANT TO SECTION 2-322 OF THE CITY CODE OF ORDINANCES, APPROVING THE PURCHASE OF SIX (6) PORTABLE P7350 RADIOS IN AN AMOUNT NOT TO EXCEED \$20,820.54 FROM MIAMI-DADE COUNTY; AUTHORIZING THE CITY MANAGER AND THE CITY ATTORNEY TO NEGOTIATE AND ENTER INTO AN AGREEMENT WITH MIAMI-DADE COUNTY ON THE BASIS OF SAID TERMS; PROVIDING FOR IMPLEMENTATION; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, the City of Doral (the "City") seeks to purchase six (6) Portable P7350 radios;

WHEREAS, section 2-322 of the City Code provides that the City is authorized to enter into bids or contracts entered into by other governmental authorities provided that the governmental authority has followed a competitive bidding procedure leading to the award of the bid or contract in question which is substantially similar to the competitive bidding procedure outlined in the City Code; and

WHEREAS, in 2015 and 2016, via Resolution 15-77 and 16-53, the City purchased a total of 29 Radios from Miami-Dade County, after it was determined that Miami-Dade pricing bested any prices obtained by the City in its own competitive bidding; and

WHEREAS, Staff, now, has recommended that the City Council open a purchase order for the purchase of 6 Portable P7350 Radios, with accessories and programming in an amount not to exceed \$20,820.54 with Miami Dade County. This purchase is funded in account 001.60005.500640 Capital Outlay-Office; and

WHEREAS, Staff further recommends that the City Council authorize the City Manager and the City Attorney to negotiate and enter into an agreement with Miami-Dade County.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL
OF THE CITY OF DORAL, FLORIDA, AS FOLLOWS:

<u>Section 1.</u> Recitals. The above recitals are confirmed, adopted, and incorporated herein and made a part hereof by this reference.

Section 2. Approval. The City Manager is hereby authorized the purchase of 6 Portable P7350 Radios, with accessories and programming in an amount not to exceed \$20,820.54 from Miami Dade County. This purchase is funded in account 001.60005.500640 Capital Outlay-Office.

<u>Section 3.</u> <u>Implementation.</u> The City Manager and the City Attorney are hereby authorized to take such further action as may be necessary to implement the purpose and provisions of this Resolution.

<u>Section 4.</u> <u>Effective Date.</u> This Resolution shall become effective immediately upon its adoption.
