## **RESOLUTION NO. #2006-43**

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF DORAL. FLORIDA: ESTABLISHING A PROPOSED MILLAGE RATE OF 2.447 TO BALANCE THE GENERAL FUND FOR FISCAL YEAR 2006-2007, ESTABLISHING THE CURRENT ROLLED-BACK RATE TO BE 2.0034 ESTABLISHING THE FIRST AND THE SECOND PUBLIC BUDGET HEARINGS AS REQUIRED BY LAW; DIRECTING THE CLERK AND MANAGER TO FILE SAID RESOLUTION WITH THE PROPERTY APPRAISER OF MIAMI-DADE COUNTY PURSUANT TO THE REQUIREMENTS OF STATUTES AND THE RULES AND REGULATIONS OF THE DEPARTMENT OF REVENUE OF THE STATE OF FLORIDA; ESTABLISHING THE TIME AND LOCATION OF THE FIRST AND SECOND PUBLIC HEARINGS: PROVIDING FOR AN **EFFECTIVE DATE** 

WHEREAS, on July 1, 2006 the Honorable Frank E. Jacobs, Property Appraiser of Miami-Dade County, Florida, served upon The City of Doral, A "Certification of Taxable Value" certifying to The City of Doral its 2005 taxable value: and

WHEREAS, the provisions of Florida Statutes Section 200.065 require that within thirty five (35) days of service of the Certification of Taxable Value upon a municipality, said municipality shall be required to furnish to the Property Appraiser of Miami-Dade County the proposed millage rate, the current year roll back rate, and the date, time and place at which a first public hearing will be held to consider the proposed millage and tentative budget; and

WHEREAS, The City Council desires to announce the dates of the first and second hearings to the Property Appraiser of Miami-Dade County; and

WHEREAS, The City Council has reviewed the figures supplied by the Property Appraiser of Miami-Dade County and that being otherwise fully advised in the premises;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA AS FOLLOWS:

**Section 1.** That the proposed millage for the first public hearing is hereby declared to be <u>2.447</u> mills which is \$<u>2.447</u> per \$1,000.00 of assessed property within the City of Doral.

<u>Section 2.</u> That the City Council further confirms the current year rolled back rate, computed pursuant to section 200.065 F.S., is \$2.0034 per \$1,000.00.

<u>Section 3.</u> That the date, time and place of the first and second public hearings is hereby set by The City Council as follows:
