

# Twitter Accuses Texas AG of Retaliation Over Trump Ban

Twitter Inc. is asking a California federal court to halt an investigation into its confidential content moderation procedures brought by the Texas Attorney General's Office after the company banned ex-President Donald Trump from its platform.

Attorneys from Wilmer Cutler Pickering Hale and Dorr are representing Twitter in the complaint against Attorney General Ken Paxton, which accuses Paxton of retaliating against the social media giant for suspending Trump.

Trump was de-platformed by the micro-blogging app in the final weeks of his presidency.

The lawsuit, filed in the U.S. District Court for the Northern District of California Monday, asserts that Paxton issued a civil investigative demand just five days after the company announced its ban of Trump. The Attorney General's Office demanded "volumes of highly confidential documents concerning Twitter's internal content moderation processes—the public disclosure of which would undermine their effectiveness, and compromise Twitter's ability to effectively and efficiently moderate content on its platform," according to the complaint, which was surfaced by Law.com Radar.

Twitter alleges that Paxton violated the First Amendment by issuing the investigation targeting its editorial practices. The company says in the lawsuit that it attempted to work with Paxton to tailor the document requests but did not reach an agreement.

"Instead, AG Paxton made clear that he will use the full weight of his office, including his expansive investigatory powers, to retaliate against Twitter for having made editorial decisions with which he disagrees," wrote Wilmer attorneys Patrick Carome, Ari Holtzblatt, Peter Neiman and Mark Flanagan.

"Now Twitter, already targeted because of its protected activity, is left with the untenable choice to turn over highly sensitive documents or else face legal sanctions."

Twitter is seeking an order declaring that Paxton violated the tech firm's free speech rights and a temporary restraining order enjoining the office from continuing the investigation.

A Twitter representative said Paxton is misusing the powers of his office in an attempt to silence free speech. "As we've repeatedly stated, and recent research underscores, we enforce the Twitter Rules judiciously and impartially across our service," the representative said in an email statement. "In the words of AG Paxton: '...[i]t is one thing to use the legal system to pursue public policy outcomes; but it is quite another to use prosecutorial weapons to intimidate critics, silence free speech, or chill the robust exchange of ideas.'"

Paxton's office did not immediately respond to a call and email late Monday evening.

# DuCharme Announces Resignation As Acting US Attorney in New York

Acting U.S. Attorney Seth DuCharme of the Eastern District of New York told his staff he will be resigning effective March 19, the office confirmed in a news release.

Mark Lesko, who has served as first assistant in the office, is expected to take the reins as acting U.S. attorney until President Joe Biden nominates a replacement. DuCharme, meanwhile, said he plans to move into private practice.

DuCharme has served in the top role for less than a year. In July, he and former U.S. Attorney Richard Donoghue swapped roles, with Donoghue moving to Washington to become principal associate deputy attorney general to then-Attorney General William Barr. DuCharme had moved to the nation's capital after serving as chief of the Eastern District's criminal division.

DuCharme once worked as an associate at Simpson Thacher & Bartlett

and served in the U.S. Marshals Service. Before rising to chief of the criminal division, he was the Eastern District's chief of national security and cybercrime.

"At each stage of my career, I was blessed to be faced with worthy challenges on behalf of the American people," DuCharme said in a statement Monday. "My time in EDNY and the Department gives me great confidence that the American people are well served by forward leaning professionals, who put mission first, and assume risks every day on behalf of the people they are sworn to serve."

DuCharme said he expects that the office "will function smoothly and effectively" amid the transition to Lesko's leadership. He described Lesko as "a proven professional who has served the district and the nation with distinction."
