

**RESOLUTION No. 24-61**

**A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AUTHORIZING MUNICIPAL SPONSORSHIPS TO MY SAFE SCHOOLS M-DCPS IN THE AMOUNT OF \$1,666.66; THE GUARDIANS OF HUMAN RIGHTS FOUNDATION IN THE AMOUNT OF \$1,666.66 AND EDUCATION FOR ALL, INC IN THE AMOUNT OF \$1,666.66, PURSUANT TO SECTION 2-79 OF THE CITY'S CODE OF ORDINANCES; PROVIDING FOR AUTHORIZATION; PROVIDING FOR IMPLEMENTATION; AND PROVIDING FOR AN EFFECTIVE DATE**

**WHEREAS**, Section 2-79 of the Code of Ordinances for the City of Doral ("City") governs municipal sponsorships and provides that each councilmember is allotted \$ 5,000.00 per fiscal year (contingent upon annual city budget approval), to sponsor eligible applicants whose events, services, and programs support the city's vision, mission, and values as set forth in the city's adopted strategic plan and provide a community benefit; and

**WHEREAS**, in a continued commitment to supporting non-profit organizations, Mayor Fraga proposes sponsorship for three foundations; and

**WHEREAS**, My Safe Schools M-DCPS is a non-profit organization, whose primary goal is to promote the safety and well-being of students in Miami-Dade County public schools. This organization actively works to prevent and address cases of gun violence and bullying, through prevention, training, and awareness programs aimed at students, parents, teachers, and school staff; and

**WHEREAS**, in accordance with Section 2-79 of Municipal Sponsorships, Mayor Christi Fraga proposes a donation of \$1,666.66 to My Safe Schools M-DCPS; and

**WHEREAS**, the Guardians of Human Rights Foundation was established to empower members of our community to understand and assert their individual and universal rights while guiding them to build communities grounded in democratic ideals.

The work of the Guardians of Human Rights Foundation is to empower individuals and communities to protect their rights aligned with our city's values of respect, dignity, and equality for all; and

**WHEREAS**, in accordance with Section 2-79 of Municipal Sponsorships, Mayor Christi Fraga proposes a donation of \$1,666.66 to the Guardians of Human Rights Foundation; and

**WHEREAS**, Education for All, Inc is a powerful tool for empowerment and social mobility. Education for All Inc.'s dedication to providing Hispanic students with the resources and support needed to access higher education not only benefits the students themselves but also enriches our community by fostering a more educated and diverse workforce; and

WHEREAS, in accordance with Section 2-79 of Municipal Sponsorships, Mayor Christi Fraga proposes a donation of \$1,666.66 to Education for All, Inc; and

**WHEREAS**, the City Council finds that the proposed municipal sponsorship complies with Section 2-79 of the City's Code of Ordinances, and finds that the donations to the Foundations mentioned serve a municipal purpose.

**NOW THEREFORE, BE IT RESOLVED BY THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AS FOLLOWS:**

**Section 1. Recitals.** The above recitals are true and correct and incorporated herein.

**Section 2. Approval & Authorization.** The Mayor and City Council hereby approve the municipal sponsorship proposed by Mayor Christi Fraga to My Safe Schools

M-DCPS, The Guardians of Human Rights Foundation, and Education for All, Inc. The City Manager is hereby authorized to expend the budgeted funds.

**Section 3. Implementation.** The City Manager is hereby authorized to take such action as may be necessary to implement the provisions of this Resolution.

**Section 4. Effective Date.** The Resolution shall take effect immediately upon adoption.


The Prime Sponsor of the foregoing resolution is Mayor Christi Fraga.

The motion was seconded by Councilmember Pineyro and upon being put to a vote, the vote was as follows:


