A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, APPROVING THE AWARD OF REQUEST FOR PROPOSALS #2018-27 "OFFICIATING AND SCOREKEEPING SERVICES" TO THE TOP RANKED FIRM AND AUTHORIZING THE CITY MANAGER TO NEGOTIATE AND ENTER INTO AN AGREEMENT WITH MIAMIBASKETBALL.NET FOR A PERIOD OF TWO (2) YEARS; PROVIDING FOR IMPLEMENTATION; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, On September 4, 2018, Request for Proposals #2018-27, "Officiating and Scorekeeping Services" was advertised for the provision of providing officiating and scorekeeping services for the City of Doral Parks & Recreation Department; and

WHEREAS, On September 17, 2018 a mandatory pre-bid meeting was held in which two (2) firms attended; and

WHEREAS, One (1) proposal submittal was received by the October 1, 2018 deadline with the received proposal meeting the required criteria set forth in the RFP; and

WHEREAS, an evaluation meeting was held on October 17, 2018, where the committee made an award recommendation based on a three hundred (300) point system for each group. The firm ranked as follows for each group.

Group A- Youth Sports

1. MiamiBasketball.Net 279 points

Group B- Adult Sports

1. MiamiBaskebtall.Net 280 points

WHEREAS, Staff respectfully requests the approval to award Request for Proposals #2018-27 "Officiating and Scorekeeping Services" to the top ranked firm and authorize the City Manager to negotiate and enter into an agreement with

MiamiBasketball.Net for the provision of providing officiating and scorekeeping services for a period of two (2) years.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AS FOLLOWS:

<u>Section 1.</u> <u>Recitals.</u> The above recitals are confirmed, adopted, and incorporated herein and made a part hereof by this reference.

<u>Section 2. Approval of Services.</u> The award of Request for Proposals #2018-27 to MiamiBasketball.Net for the provision of providing officiating and scorekeeping services for the City of Doral Parks & Recreation Department is hereby approved.

<u>Section 3.</u> <u>Authorization to Procure Services.</u> The City Manager is hereby authorized to negotiate and enter into an agreement with MiamiBasketball.Net for the provision of providing officiating and scorekeeping services for the City of Doral Parks and Recreation Department for a period of two (2) years. The agreement is subject to approval by the City Attorney as to form and legal sufficiency and on such other terms and conditions as may be appropriate to protect and further the interests of the City. This Authorization does not create or confer any rights to MiamiBasketball.Net or any of the other ranked firms. Funding for this service will come from the Parks & Recreation account 001.90005.500340.

Section 3. Implementation. The City Manager and the City Attorney are hereby authorized to take such action as may be necessary to implement the provisions of this Resolution.

Section 4. Effective Date. This resolution shall take effect immediately upon adoption.
