A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AUTHORIZING THE CITY MANAGER TO UTILIZE OMNIA CONTRACT No. 2019-001535 FOR THE DORAL LEGACY PARK AUDIOVISUAL REFRESH PROJECT FROM AVI SPL, AS WELL AS A WAIVER OF COMPETITIVE BIDDING AS TO THE NUMBER OF HOURS OF LABOR, ALL IN AN AMOUNT NOT TO EXCEED \$221,503.20; PROVIDING FOR AUTHORIZATION; PROVIDING FOR IMPLEMENTATION; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, the City of Doral's("City") Legacy Park audiovisual (AV) equipment refresh project is necessary due to the facility's constant use since its opening on August 12, 2017; and

WHEREAS, Council approved Resolution 16-147 on August 10th, 2016, authorizing the purchase of the original AV equipment for the park. However, the current equipment has experienced breakdowns that have required repairs, which were covered during the warranty periods. Unfortunately, these warranties have expired, and the equipment is no longer covered; and

WHEREAS, the Doral Legacy Park AV equipment refresh project aligns with the strategic goals of exceptional service and parks and recreation by enhancing the quality and accessibility of services provided to; and

WHEREAS, the City Manager respectfully requests that the Mayor and City Councilmembers authorize the use of OMNIA Partners Contract No. 2019.001535 Audio Visual Goods and Services for the Doral Legacy Park audiovisual refresh project from AVI SPL in an amount not to exceed \$221,504. Funds are allocated in the IT Capital Outlay – Other account 001.22005.500652.
