ARTICLE V OF THE CITY CODE; AND TO ENTER INTO AN AGREEMENT WITH THE PREQUALIFIED POOL OF VENDORS FOR THE PROVISION OF GASOLINE AND DIESEL, TRANSPORT AND TANK WAGON IN AN AMOUNT NOT TO EXCEED ANNUAL BUDGETED FUNDS: AUTHORIZING THE CITY MANAGER TO ADOPT THE EXISTING MIAMI-DADE COUNTY CONTRACT AND TO EXPEND BUDGETED FURTHERANCE HEREOF: **PROVIDING FUNDS** IMPLEMENTATION: AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, on June 13, 2018, the Mayor and the City Council adopted the State of Florida Contract No. 405-000-10-1, that expires on June 30, 2019, with Petroleum Traders, Corp. and Mansfield Oil Company, LLC via Resolution No. 18-111 (approved 5-0) for the provision of fuel supply; and

WHEREAS, in an effort to continue to provide the highest quality service possible, in a timely and cost efficient manner, the Public Works Department (PWD) recommends the adoption of the MDC Contract No. ITQ-676-18-A to expand the list of vendors that can meet the City's fuel consumption requirements, and can provide fuel services on a priority basis during emergency conditions that may disrupt the availability of fuel in the area; and

WHEREAS, pursuant to Section 2-322 of the City Code, staff respectfully request authorization for the City Manager to adopt the existing Miami-Dade County Contract No. ITQ-676-18-A, and enter into agreements with the prequalified pool of vendors

(Sunshine Gasoline Distributors, Pro Energy LLC, Mansfield Oil Company of Gainesville Inc, and Urbieta Oil Inc) and any additional vendor that may be added to the County's pool for the term of the contract and any extension periods for the provision of Gasoline and Diesel, Transport and Tank Wagon, in an amount not to exceed annual budgeted funds; and

WHEREAS, funds for these services were budgeted in the current fiscal year in Public Works account number 001.80005.500522 – Operating Supplies – Vehicles.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DORAL AS FOLLOWS:

<u>Section 1.</u> Recitals. The above recitals are confirmed, adopted, and incorporated herein and made part hereof by this reference.

Section 2. Authorization. Funds for these services were budgeted in the current fiscal year in Public Works account number 001.80005.500522 – Operating Supplies – Vehicles.

## AGREEMENT BETWEEN THE CITY OF DORAL, FLORIDA AND SUNSHINE GASOLINE DISTRIBUTORS

This Agreement ("Agreement") made up this 12th day of June 2019, by and between the City of Doral, Florida, a municipal corporation of the State of Florida ("City") and Sunshine Gasoline Distributors ("Contractor") having its place of business at 1650 NW 87th Avenue Doral, FL 33172, for the purchase of Gasoline and Diesel.

WHEREAS, the Contractor has an active agreement with the Miami Dade County (Contract No. ITQ-676-18-A), dated October 1, 2018, which was competitively entered into in a manner consistent with Chapter 2 of the City Code; and

WHEREAS, on May 8, 2019 the Mayor and the City Council members adopted Resolution No. 19-126 authorizing the City Manager to enter into an agreement with the Contractor, for the purchase of Gasoline and Diesel, based on the Miami Dade County Contract (No. ITQ-676-18-A) in an amount not to exceed the departmental budgeted funds.

**NOW THEREFORE**, in consideration of the mutual covenants set forth in this Agreement, the parties agree as follows:

- Section 1. Recitals. The above recitals are true and correct and incorporated herein.

The City of Doral agrees to the purchase of Gasoline and Diesel fuel from and Sunshine Gasoline Distributors and Sunshine Gasoline Distributors agrees to sell to the City Gasoline and Diesel fuel pursuant to the terms and conditions set out in Miami Dade County Contract No. ITQ-676-18-A.
- Section 3. All terms and conditions of the Miami Dade County Contract No. ITQ-676-18-A are adopted and incorporated in this agreement. Miami Dade County Contract No. ITQ-676-18-A. is attached as Exhibit "A".
- Section 4. Sunshine Gasoline Distributors shall comply with the terms and conditions set forth in the Miami Dade County Contract No. ITQ-676-18-A and agrees that the City of Doral may access Miami Dade County Contract No. ITQ-676-18-A.
- Section 5. Governing Law and remedies shall be amended as follows: "The validity of this agreement and any terms and provisions as well as all rights and duties of the parties here under shall be governed by the laws of the State of Florida and the venue shall be Miami-Dade County."
