WHEREAS, the City of Doral (the "City") issued Invitation to Bid #2014-40, titled Floating Debris Removal Services (the "ITB"), for which the City received one (1) response by the November 11, 2014 submittal deadline, attached hereto as Exhibit "A", which is incorporated herein and made a part hereof by this reference; and

WHEREAS, having reviewed the bid submitted, City Staff has recommended that the Mayor and City Council award the bid to SFM Service, Inc. and authorize the City Manage to enter into an agreement with SFM Service, Inc. for the provision of floating debris removal services in an amount not to exceed \$183,072.00 for a four (4) year period.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DORAL AS FOLLOWS:

<u>Section 1.</u> Recitals. The above recitals are confirmed, adopted, and incorporated herein and made a part hereof by this reference.

Section 2. Approval of Award. SFM Service, Inc. is hereby awarded the bid for Floating Debris Removal Services, pursuant to the terms of the ITB, the submitted bid, and an agreement to be executed with the City.

<u>Section 3.</u> <u>Authorization.</u> The City Manager is hereby authorized to enter into an agreement with SFM Service, Inc., subject to approval by the City Attorney as to form and legal sufficiency, for the provision of Floating Debris Removal Services, in an amount not to exceed \$183,082.00 in a four (4) year period, and to expend budgeted funds on behalf of the City in furtherance hereof;

<u>Section 4.</u> <u>Implementation.</u> The City Manager and City Attorney are hereby authorized to take such further action as may be necessary to implement the purpose and provisions of this Resolution.

<u>Section 5.</u> <u>Effective Date.</u> This Resolution shall take effect immediately upon adoption.
