

# CITY OF DORAL Commission on the Status of Women Advisory Board Meeting Minutes

# Thursday, September 10th, 2015 3rd Floor Training Room Doral, FL 33166

1. Meeting was called to order at 6:05pm

### 2. Roll Call of Members:

### 3. Public Comments:

- Debra Dion from the South Florida Voices for Working Families made an intervention regarding the Miami-Dade Healthy Families Act and provided documentation for all the members to review,
- Mercedes Echavarria from Doral Works introduced herself as member of the press, she will be attending our meetings and offered to promote any events that we may have.

### 4. Approval of Minutes

Minutes for meeting on July 9th were read and approved unanimously by all members present.

### 5. Agenda/Order of Business

- Feedback on report and to City Council on 8/11/15:
  - Tina Floyd reported back to the board that Council had approved the budget for the film screening scheduled for October 15<sup>th</sup>.
  - Alejandra Moreno reported that she had met with City Attorney, City Manager and the Parks and Recreation Director to follow up on the items below:.
    - o Kristie House Training:
      - The City Manager and Attorney indicated they believe having Parks employees that work with children take the Kristie House training is a liability to the City.

Alejandra Moreno explained that it is an awareness training could only benefit the children that they come in contact with. Chapter 39 of the Florida Statutes states that everyone in the state is a mandated reporter (\* see attachments referenced at the bottom\*). It was agreed that Alejandra would reach out to Kristie House and have them come and explain to City Management why lack of training would be a greater liability than to promote awareness within staff. City Attorney also asked to research if other municipalities had this training.

All board members expressed their desire to be present in this meeting to offer their support on this topic – topic that has already been discussed and approved by the

board. Maggie will review with the City Attorney if this would be a breach of Sunshine Law, given that the item has already been voted on in a public meeting.

### The Envelope Resolution

The City Attorney had misunderstood that this initiative included City of Doral's printing of envelopes. Alejandra explained that the request was for a resolution to encourage local Doral hotels, in particular the Trump Doral resort to support this nationwide initiative. She also explained that the Miami-Dade County Commission on Women had provided their resolution as a sample or to serve as a basis to the City of Doral Resolution. City Attorney communicated that he would draft such resolution – the intention was to present it during the August meeting, however it was not presented in August nor in September. Maggie will follow up with the City Attorney to provide feedback to the board on the delay.

### Film Screening

During the meeting, the initiative was discussed with City Manager who stated that he would support the effort

  - Board members will also distribute to the COSW mailing list and sharing City's social media posts
  - Moderator: we will need a moderator for the film forum Alejandra will reach out to Nataly French, Ana will reach out to Nataly Salas to see if they would be interested in moderating to forum.
  - It was decided that the theme for refreshments would be for a movie night: hot dogs, chips, popcorn, soda, coffee and sweets – details of who will be purchasing will be discussed during the October regular meeting (before the event)
  - o Facilities have been secured for date of event: 10/15/15 @7:00pm
