A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AUTHORIZING THE CITY MANAGER TO UTILIZE CARAHSOFT FLORIDA NASPO VALUEPOINT CLOUD SOLUTION AGREEMENT No. 43230000-NASPO-16-ACS, FOR THE PURCHASE OF VERITAS ALTA DATA MANAGEMENT SOLUTION FROM UNITED DATA TECHNOLOGIES IN AN AMOUNT OF \$130,837.98; PROVIDING FOR AUTHORIZATION; PROVIDING FOR IMPLEMENTATION; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, the City of Doral current contract for both licenses and software solution support for Veritas FSA and EV ended on January 22, 2024. As these solutions are provided by Veritas Technologies, a renowned company specializing in data management and protection, we embarked on a thorough evaluation of our current needs and future requirements. Following this assessment, we have decided to transition to Veritas Alta as our primary data management solution; and

WHEREAS, transitioning to Veritas Alta represents a significant step forward in our data management strategy. Alta offers a comprehensive platform addressing the evolving challenges of modern data environments. By adopting Alta, we aim to streamline our data management processes, enhance operational efficiency, and leverage data as a strategic asset effectively; and

WHEREAS, the City Manager respectfully requests that the Mayor and City Council Members authorize the use of Carahsoft Florida NASPO ValuePoint Cloud Solutions Agreement # 43230000-NASPO-16-ACS for the transition from Veritas FSA (File System Archiving) and EV (Enterprise Vault) to Veritas Alta in a 3-year agreement from United Data Technologies (UDT) in an amount not to exceed \$130,837.98. Funds

are allocated in the IT Maintenance and Repair account 001.22005.500460.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AS FOLLOWS:

Section 1. Recitals. The above recitals are confirmed, adopted, and incorporated herein and made a part hereof by this reference.

Section 2. Approval and Authorization. The City Manager requests that the Mayor and City Council Members authorize the use of Carahsoft Florida NASPO ValuePoint Cloud Solutions Agreement # 43230000-NASPO-16-ACS for the transition from Veritas FSA (File System Archiving) and EV (Enterprise Vault) to Veritas Alta in a 3-year agreement from United Data Technologies (UDT) in an amount not to exceed \$130,837.98, is hereby approved. Funds are allocated in the IT Maintenance and Repair account 001.22005.500460.

Section 3. Implementation. The City Manager and City Attorney are hereby authorized to take such further action as may be necessary to implement the purpose and provisions of this Resolution.

Section 4. Effective Date. This Resolution shall take effect immediately upon adoption.


