# **RESOLUTION No. 20-07**

A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, PURSUANT TO SECTION 2-321 OF THE CITY'S CODE OF ORDINANCES, WAIVING THE COMPETITIVE BID PROCESS AND AUTHORIZING THE CITY MANAGER TO ISSUE A WORK ORDER TO WOLFBERG ALVAREZ AND PARTNERS IN AN AMOUNT NOT TO EXCEED \$14.850.00 FOR THE DESIGN OF THE REAL INFORMATION CENTER TO BE CONSTRUCTED AT THE POLICE DEPARTMENT FACILITY: AUTHORIZING THE CITY MANAGER TO EXPEND BUDGETED FUNDS IN THE CURRENT FISCAL YEAR 2019-"CONSTRUCTION PROGRESS". ACCOUNT 2020 IN No. 001.80005.500650 IN FURTHERANCE HEREOF: PROVIDING FOR IMPLEMENTATION: AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, the Doral Police Department Real Time Crime Information Center (RTIC) will provide the City of Doral with innovative technology that will allow the Doral Police Department (DPD) officers to respond quickly, or even immediately, to crime events more efficiently, more deliberately, with improved operational intelligence, and with a proactive emphasis on officer, citizen, and community safety; and

WHEREAS, the DPD facility is equipped with an Emergency Backup Generator to assure building operations when a power outage occurs; however, when the transition from FPL to Generator power occurs, there is an approximate 5 seconds delay for the generator to start operating. In this power transition, any system without a UPS will shut down, interrupting operations, and potentially causing the loss of information and or data that it's not saved. The interruption of operations could take as long as 10 minutes while affected equipment is manually turned on, all systems get restored and operating software are uploaded again; and

WHEREAS, in order to provide the highest quality service to the community, the DPD must always remain vigilant; and

WHEREAS, on September 11, 2019, the Mayor and the City Council-Members approved a budget transfer to secure funding for the DPD RTIC Information Technology (IT) needs via Resolution No. 19-212 (approved 4-0, 1 absentee); and

WHEREAS, on October 8, 2019, the Mayor and the City Council-Members adopted Resolution No. 19-257 (approved 4-0, 1 absentee) approving a budget transfer towards the design and installation of the Uninterrupted Power Supply (UPS) that will serve the RTIC and the Emergency Operation Center (EOC); and

WHEREAS, the Public Works Department (PWD) reached out to Wolfberg, Architect of Record (AOR), to provide an estimate in an amount of \$14,850.00 for the design and development of a set of Construction Documents for the design of the improvements; and

WHEREAS, the PWD considers that issuing a WO to Wolfberg is in the best interest of the City as Wolfberg already knows the building and its systems; Wolfberg has been the AOR for the original design and all design modifications and expansions that the building has had including but not limited to the Public Works/Police Conversion, the Police/Public Works Expansion, and the new Doral Emergency Operations Center EOC; this knowledge of the building will reduce the production time; and

WHEREAS, respectfully requests the waiving of the competitive bid process, pursuant to section 2-321 of the City of Doral Code of Ordinances, and respectfully requests authorization from the Mayor and City Council for the City Manager to issue a

Work Order to Wolfberg Alvarez & Partners in an amount not to exceed \$14,850.00 as it is in the best interest to the City; and

WHEREAS, funding for this request is available from the Public Works Department Fund, FY 2019-2020, Account Number #001.80005.500650.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DORAL AS FOLLOWS:

<u>Section 1.</u> Recitals. The above recitals are confirmed, adopted, and incorporated herein and made part hereof by this reference.

Section 2. Approval. The Work Order between the City of Doral and Wolfberg Alvarez & Partners for the design and development of a set of Construction Documents of the Real Time Information Center to be constructed at the Police Department Facility, in an amount not to exceed of \$14,850.00, a copy which is attached as Exhibit "A", is hereby approved.

<u>Section 3.</u> <u>Authorization</u>. The City Manager is authorized to waive competitive bidding, execute the Work Order, and expend budgeted funds on behalf of the City in furtherance hereof.

<u>Section 4.</u> <u>Implementation.</u> The City Manager and the City Attorney are hereby authorized to take such further action as may be necessary to implement the purpose and the provisions of this Resolution.

<u>Section 5.</u> <u>Effective Date.</u> This Resolution shall take effect immediately upon adoption.
