3. Pledge of Allegiance

4. Public Comments

Ms. Joanne Fitzgerald speaks before the Board about support from U.S. Army Garrison-Miami and U.S. Southern Command. Concerning the Memorial Day event sponsored by the city, Garrison has found a bugler but has to confirm they are available for the event. The Command is sponsoring a Commissary to Go on June 1. Intent is for eligible veterans and families to register and order online at the Commissary 2 weeks in

advance, and on Saturday, order will be ready for pick-up. Ms. Fitzgerald will send an email with information on both subjects to the Board.

Mr. Mark Pinilla noted upcoming events, Mission BBQ is looking for someone to sing the National Anthem for Armed Forces Day opening events, date and time not identified.

5. Approval of Minutes

a. April 2, 2024

Motion to approve the April 2 meeting minutes made by Vice Chair Bautista and seconded by Member Martin. By consensus, motion passes unanimously.

6. Discussion Items

a. Health Fair

Intent is to hold the health fair in conjunction with the family day event. Health fair vendors intended to be inside, with veteran support vendors outside in tents. Request availability of Glades Park for November 16 or 23, week following Veterans Day but before Thanksgiving week.

b. Memorial Day

May 27. Requested wreath should be included into the requested funds from the City. Request from the City to include in this request finger foods, drinks, items for social gathering after the event. Estimate 50 people in attendance, increase from last year's attendance. Mr. Estrada noted that the City has a sponsor for events and request like this, and he will reach out to ensure they tap into the funds requested and be able to provide some assistance for the social gathering.

Secretary Flynn will provide an agenda to the City, formalized from April minutes. Chair Watts and Secretary Flynn will arrive early at the park to take possession of the wreath delivery. Mr. Estrada will reach out to the Parks Director, who has previously ordered the wreath. She will reach out to Chair Watts for a delivery time.

Request support of a mic and speaker system through Vet Info. Vet Info will seek 5 volunteers to support this event.

Ms. Fitzgerald will reach out to U.S. Southern Command - command section to see who is available to attend, or to be a guest speaker. The General and SgtMaj are both traveling during this event.

Noted to the Mr. Estrada previous years but for single Council Member last year, City Council has never been in attendance for this event. Mr. Estrada will send a message to the Communications Director to add this event to the Council Member calendars as awareness.

Member Fitzgerald requested outreach, partner, with various veteran agencies to support this event, and future events. Ms. Pinilla noted several organizations that Vet Info has partnered with, to include Student Veterans of America, Mission United, Young Marines, and Wounded Warrior Project.

Ms. Fitzgerald asked how the City has previously advertised this event, suggested an Eventbrite advertisement, of no cost. Mr. Estrada will reach out to Public Affairs. Vice Chair Bautista noted potential need for police support for traffic and parking. Chair Watts will conduct outreach for potentially 1 officer on duty that can also participate in the event.

c. Armed Forces Day.

May 18. Previous minutes listed June 29, incorrect date. Secretary Flynn read the letter. Member Fitzgerald noted the order of precedence when listing the services together, usually the oldest to the youngest.

Board concern is finalizing the letter and getting it delivered to U.S. Southern Command before the weekend.

Mr. Estrada will reach out to the City Clerk, Connie Diaz, to discuss the letter, getting it printed, May and Council Member signatures, and delivery to U.S. Southern Command by May 16. U.S. Southern Command - Command Section will be out May 17.

d. Veteran's Family Day Event.

2023 Eventbrite registered 146 people just before the event date. This does not reflect non-registered attendees.

Mr. Estrada will reach out to offices that worked on the invitation used in previous years.


