NOTICE: Pursuant to the Procurement Ordinance, the City of Doral (the "City") hereby gives notice of its intent to seek sealed proposals from interested parties in response to this Request for Proposals for "RFP No. 2021-09 - Construction of Pedestrian Bridge" (the "RFP") to provide the services described herein. Proposals must be received by **5:00 P.M. on April 27, 2021.**

All proposals shall be publicly opened and recorded on 5:00 P.M. on April 27, 2021. Late submittals shall not be accepted or considered. Responses must be submitted electronically through DemandStar or Vendor Registry by the date and time stated above. Any proposals received after the due date and time specified, will not be considered. See attached instructions for further details on E-Bidding. **Emailed or** faxed submittals will not be accepted.

The City of Doral reserves the right to accept any bid deemed to be in the best interest of the City or to waive any informality in any submittal. The city may reject any or all bids and re-advertise

PROJECT OVERVIEW

The City of Doral desires to retain the services of a qualified Design/Build Contractor to design and construct the Doral Pedestrian Bridge over NW 41st Street at Homestead Extension of Florida's Turnpike (HEFT) within the City of Doral, in Miami Dade County to include all efforts for final design and construction of a Pedestrian Bridge Facility. The proposed pedestrian bridge will span over NW 41st Street in the vicinity of the HEFT and will provide residents and visitors a needed link between existing Turnpike Trail shared used paths north and south of NW 41st Street/Doral Boulevard, a heavily traveled arterial within the City of Doral. While this structure will facilitate pedestrian and bicyclist safety and mobility, its construction will also serve as a gateway into the City from the Florida's Turnpike.

The Proposer and/or is Subconsultants/Subcontractors shall, at time of award and throughout duration of the Contract, be pre-qualified in the following work classes.

In order to verify the Proposer and/or its Subconsultants/Subcontractors are pregualified under Rule 14-22 and Rule 14-75 of the F.A.C for the above classifications of work, the Proposer shall submit current FDOT Certificate of Classifications Letters and FDOT Notice of Qualification Letters. A statement without supporting information/documentation will not meet this mandatory requirement. A prequalification report is not acceptable evidence to substantiate qualification.

If Proposer shall subcontract for some of the classifications of work listed above, the Proposer shall identify those classifications of work that will be performed by the Proposer and those that will be subcontracted. The lead design consultant must be pre-qualified in all design and structural work types shown above as (PRIME) and as proposed by the Design-Build Firm. The remaining qualification requirements for work types can be fulfilled by subconsultants.

Bid shall include all charges that may be imposed in fulfilling the RFP and Technical Specifications in this solicitation. The maximum budget amount for this project shall not exceed \$4,800,000 (four million eight hundred thousand dollars). Any submitted bid amount exceeding the maximum budget amount shall be deemed non-responsive

SELECTION PROCESS

The City of Doral will select the successful proposer based on ADJUSTED SCORE, where the City will conduct a two-phase design-build procurement process. For Phase I, qualified Design-Build Firms must submit a Letter of Interest (LOI) to the indicated requesting unit by the time and date indicated as the Response Deadline.

The maximum number of pages shall be 5, paper size 81/2" x 11", single-sided, typed pages including text, graphics, tables, charts, and photographs. Double-sided 8½" x 11" sheets will be counted as 2 pages. 11"x17" sheets are prohibited except for one sheet for Organizational Chart which shall not count towards the 5-page limit. A cover page may be provided and does not count towards the five (5) page limitation. All font (including graphics, tables, and captions on photos) must be standard Arial narrow, 11-point font, single line spacing with no modification of font or spacing allowed.

The LOI shall include at minimum key personnel proposed as participating in the Project. Resumes may be separately submitted but are limited to one 8½"x11" page each. Resumes are not counted toward the five (5) page limitation. Please provide one (1) page resumes for each of the following four (4) key staff positions and up to five (5) additional resumes of personnel who best highlight the experience and expertise of the Design Build firm for the particular project, as applicable:

- Design Project Manager
- Construction Project Manager
- Construction Design-Build Coordinator Utility Coordination Manager

It is the responsibility of the Design-Build firm to ensure that the complete LOI is timely received by the City of Doral. The City will score the relative ability of each submitting Design-Build Firm to perform the required services based on qualification information and the LOI. Unless otherwise noted in the specific Design-Build advertisement, the criteria for evaluating the Phase I submittals will include:

- Design-Build Firm Name and pre-qualifications
- Past Performance Evaluations, Design-Build Project Experience, Organization, and Staffing (0-7 Total Points):
 - Contractor Grades
 - Professional Consultant Grades
 - Performance History with other States or Agencies, if none with the Department, include 0 letters of recommendations or performance grades issued by other agencies
 - Design-Build Project experience of the Contractor and Professional Consultant
 - Similar types of work experience
 - Environmental Record
 - Contractor Experience Modification Rating (Current Year)
 - Design-Build Firm organization
 - 0 Design-Build Firm staffing plan
 - Design-Build Firm coordination plan
- Design-Build Project Requirements and Critical Issues (0-13 Total Points):
 - Understanding of Design-Build Project Requirements
 - 0 Identification of critical issues
 - Outline for addressing critical issue

Relative weightings for all Phase I criteria are specified within the project advertisement. All qualified firms submitting a responsive LOI will be scored on a scale of 0-20 points (Phase I). The City of Doral will determine the short-listed firms with the objective to short-list the highest ranking LOI scores.

The City of Doral will post the Short-List to the City's website per the RFP's schedule of events. The Short-Listed Design-Build Firms will be issued a Request for Proposal (RFP). The requirements for Phase II Technical Proposals will be described in the RFP. Phase II Technical Proposals will be scored on an 80-point scale factor (100 points maximum X .80). The total score from Phase I and Phase II will be added to determine the Design-Build Firm's Technical Score (Combined Scores from LOI and Technical Proposal) and applied to the Final Selection Formula in the RFP. Unless otherwise specified in the RFP, the award of the Project will be determined on an Adjusted Score as shown in the RFP based on both the Bid/Price Proposal and Technical Score.

REQUIRED FORMS
