

**RESOLUTION No. 21-157**

**A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, APPROVING A BUDGET TRANSFER IN THE AMOUNT OF \$11,103.00 FOR UNUSED FUNDS FROM HUMAN RESOURCES ACCOUNT No. 001.20005.500130 TO THE INFORMATION TECHNOLOGY ACCOUNT No. 001.22005.500310; AND PROVIDING FOR AN EFFECTIVE DATE**

**WHEREAS**, On March 17, 2021 First Reading and April 14, 2021 Second Reading of Budget Amendment in the amount of \$14,500 was transferred to HR for the purpose of an IT Part Time Intern and now a budget transfer is needed for \$11,103.00. Due to an unforeseen vacancy for full time IT Technician, the position was posted on March and May, however, after review of candidates resumes, there were no viable candidates; and

**WHEREAS**, We then requested consideration in the selection of Intern Brian Lipiz for this position. This selected IT candidate just completed performing the role of IT Intern and has worked closely with IT staff to provide support for all City facilities, systems, and hardware. Mr. Lipiz meets the minimum qualifications of a High School Diploma and 4 years of professional technical experience which are essential to perform job responsibilities; and

**WHEREAS**, Staff respectfully requests that the City Council and City Manager authorize budget transfer from Human Resources Account No. 001.20005.500130-Other Salaries to Information Technology Account No. 001.22005.500310-Professional Services in the amount of \$11,103.00 for the unused funds.

**NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL AS FOLLOWS:**

**Section 1. Recitals.** The foregoing recitals are confirmed, adopted, and incorporated herein and made a part hereof by this reference.

**Section 2. Authorization.** The City Manager is hereby authorized to transfer the amount of \$11,103.00 from Human Resources Account No. 001.20005.500130-Other Salaries to Information Technology Account No. 001.22005.500310-Professional Services.

**Section 3. Implementation.** The City Manager and the City Attorney are hereby authorized to take such further action as may be necessary to implement the provisions of this Resolution.


