

**RESOLUTION No. 24-44**

**A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AUTHORIZING THE CITY MANAGER TO UTILIZE THE TIPS CONTRACT No. 230901 FOR THE PURCHASE OF ADDITIONAL CAMERAS FOR COUNCIL CHAMBERS FROM AVI SPL IN AN AMOUNT OF \$55,604.54; PROVIDING FOR AUTHORIZATION; PROVIDING FOR IMPLEMENTATION; AND PROVIDING FOR AN EFFECTIVE DATE**

**WHEREAS**, the City of Doral's ("City") current camera setup has been crucial in capturing and broadcasting Council meetings, ensuring transparency and accessibility for our constituents; and

**WHEREAS**, the City Manager requests authorization to purchase additional cameras to enhance coverage and eliminate blind spots during Council meetings; and

**WHEREAS**, upgrading the camera equipment will also lead to improved visuals and live stream quality, which will contribute to a more professional and engaging experience for both in-person attendees and those watching remotely; and

**WHEREAS**, investing in updated cameras will allow the City to leverage the latest features and advancements in the field of video recording and broadcasting technology, ensuring we stay current with industry; and

**WHEREAS**, the City Manager respectfully requests that the Mayor and City Council Members authorize the purchase of additional cameras for the Council Chambers in the amount of \$55,604.54 pursuant to Contract No. 230901, which was competitively-bid by The Interlocal Purchasing System ("TIPS").

**NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AS FOLLOWS:**

**Section 1. Recitals.** The above recitals are confirmed, adopted, and incorporated herein and made a part hereof by this reference.

**Section 2. Approval and Authorization.** The City Manager requests that the Mayor and City Council Members authorize the purchase of additional cameras for the Council chambers in the amount of \$55,604.54 from AVI-SPL pursuant to TIPS Contract No. 230901, is hereby approved. Funds are allocated in the IT Capital Outlay – Other account 001.22005.500652.

**Section 3. Implementation.** The City Manager and City Attorney are hereby authorized to take such further action as may be necessary to implement the purpose and provisions of this Resolution.

**Section 4. Effective Date.** This Resolution shall take effect immediately upon adoption.
