4. Public Comments

Ms. Nerissa James, Doral resident, introduced a golf program designed for veterans, that is sponsored by the County. As a Doral resident, Ms. James is interested if Doral courses could be engaged in this program or support something similar. Ms. James

provided her notes, attached page 4, and program flyer, attached page 5.

Mr. Mark Pinilla spoke about the Southern Command event that Vet Info organized, included kayaking and fishing, involving veterans and their families. Vet Info is interested in holding classes for transitioning veterans, like transition assistance for military members go through before they leave service, but as a direct service program compared to awareness program offered before departing the military.

5. Approval of Minutes

a. April 4, 2023

6. Discussion Items

a. Family Day Event

Intent to hold event on Veteran's Day, Saturday, November 11. Date is subjective to City planned events for the day and ability to get sponsors that may otherwise be engaged in other services for veterans. Change of venue is requested, hold the event back at Glades, held in 2021. Parking, parking fees, space set-up, lake availability, seclusion/privacy are pluses for holding at Glades. Negative side effects were placement of fire truck, blood donation bus, placement of police motorcycles and FWC, Florida Fish and Wildlife Conservation, equipment.

Preferred park is Glades, backup Downtown park, use of City parking garage will need to be requested, as parking meters now installed directly around the park.

Secretary Flynn will gather previous years' vendor lists, vendor letter, other pertinent information for vendor participation. Will reach out to Mr. Pinilla on advertising at Glades Park for the event.

b. Health Fair for Veterans

The Board has an interest in holding a health fair, veteran focused but open for all. Intent to hold early in the new year, possibly March, a Spring health fair.

7. Open Discussion

Chair Watts posed the question to staff whether Alternate Member Isabel Martin would be appointed as full member, or if the Board would need to vote her as a full member. Mr. Estrada will ask the question and give a response back to Chair Watts.

Motion to hold vote of Vice Chair until next meeting, or at least when the Board has full staff, made by Secretary Flynn and seconded by Member Alvaro.

Mr. Estrada provided update from Public Affairs about the Military Tribute Banners. Past campaign was launched in June 2021, banners were in place for Veterans Day 2022, stayed until Memorial Day 2023. Each banner cost \$159, sponsors received banners after they were taken down. City spent \$490 for installation and removal of banners. 7 banners were purchased, 5 had to be reprinted due to weather. Previous campaign, 14 were purchased and 7 had to be replaced due to weather.
