4. Public Comments

Mrs. Flor Mayoral and Mr. Marcello Llobell representing Concrete Space Art Gallery, introduce their non-profit contemporary art museum. They explain some cultural activities the gallery has been offering in the City of Doral for more than a year. Concrete Space Art Gallery has done several exhibitions, with roughly 300 to 400 people attendance; including a FIU faculty members and students exhibition. Marcello Llobell clarifies, they would like to partner the city and he offers their venue to do talks, panels, exchange information to educating community when coming with a curator. Carmen Ramos finds in Llobell's invitation a great way to interact between amateur artists engaged with Doral government and professional artist from Concrete Space.
