A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, PURSUANT TO SECTION 2-322 OF THE CITY CODE OF ORDINANCES, APPROVING THE PURCHASE OF THE ANNUAL UPGRADE. RENEWALS. SUPPORT **VMWARE** MAINTENANCE AND FOR SOFTWARE VIA VCLOUD TECH. USING MFMP (STATE OF FLORIDA, MY FLORIDA MARKET PLACE) IN AN AMOUNT NOT TO EXCEED THE ANNUAL BUDGETED FUNDS FOR AS LONG AS VMWARE SOFTWARE IS UTILIZED BY THE IT DEPARTMENT; AUTHORIZING THE CITY MANAGER TO EXPEND BUDGETED FURTHERANCE HEREOF; PROVIDING IMPLEMENTATION; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, the City Council for the City of Doral (the "City") approved Resolutions 15-228 and 17-06 to purchase services from VMWare, for license, renewals, service and support of the existing software that operates our virtual environment; and

WHEREAS, VMWare is the existing software that operates our entire virtual environment throughout all City's facilities and the NAP location; and

WHEREAS, the Information Technology staff has reviewed the existing virtual infrastructure licenses and support needs in order to inventory our license and support renewal and bring them up to date plus expand functionality; and

WHEREAS, maintaining a current virtual software environment with the latest versions and software patches is critical to the City's infrastructure and helps align our systems with industry best practices; and

WHEREAS, staff has recommended the Mayor and City Council approve the purchase VMWare Inc.'s software renewals, upgrades, service and support for the City's licenses using purchase of annual upgrade, renewals, maintenance and support for VMWare Inc.'s Software from Vcloud Tech, using MFMP(State of Florida Market Place)

in an amount not to exceed annual budgeted funds as long as VMware Software is utilize by the IT Department. Funding for this request is available in IT Account No. 001.22005.500.460.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL
OF THE CITY OF DORAL, FLORIDA, AS FOLLOWS:

<u>Section 1.</u> Recitals. The above recitals are confirmed, adopted, and incorporated herein and made a part hereof by this reference.

<u>Section 2.</u> <u>Approval.</u> Pursuant to Section 2-322 of the City Code of Ordinances, the purchase of annual upgrade, renewals, maintenance and support for VMWare Inc.'s Software via Vcloud Tech, using MFMP(State of Florida, My Florida Market Place) is hereby approved in an amount not to exceed annual budgeted funds.

Section 3. Authorization. The City Manager is hereby authorized to enter into an agreement and other contractual documents, subject to approval as to form and legal sufficiency by the City Attorney, as may be necessary to procure the Cisco Network Equipment, and to expend funds in furtherance hereof.

Section 4. Implementation. The City Manager and City Attorney are hereby authorized to take such further action as may be necessary to implement the purpose and provisions of this Resolution.

<u>Section 5.</u> <u>Effective Date.</u> This Resolution shall take effect immediately upon adoption.
