A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, APPROVING AN OUTDOOR EVENT PERMIT FOR EVENTS MARKETING NETWORK CORPORATION TO HOST THE "DORAL FOOD & WINE FESTIVAL" AT DOWNTOWN DORAL PARK, LOCATED AT 8401 NW 53 STREET, DORAL, FLORIDA 33166 ON SATURDAY, APRIL 9, 2016 FROM 5:00PM TO 11:00PM, AND SUNDAY, APRIL 10, 2016 FROM 2:00PM TO 7:00PM; PROVIDING FOR IMPLEMENTATION; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, the Events Marketing Network Corporation ("Applicant") seeks approval from the City of Doral for an Outdoor Event Permit; and

WHEREAS, staff has recommended that Council approve the Applicant's proposed Outdoor Event Permit to host the "Doral Food & Wine Festival" on Saturday, April 9, 2016 from 5:00pm to 11:00pm, and Sunday, April 10, 2016 from 2:00pm to 7:00pm at Downtown Doral Park located at 8401 NW 53 Street, Doral, Florida 33166.

NOW THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AS FOLLOWS:

**Section 1.** Recitals. The above recitals are true and correct and incorporated herein.

<u>Section 2.</u> <u>Approval.</u> The outdoor event permit for the "Doral Food & Wine Festival" is hereby approved subject to the following conditions:

- Applicant shall comply with the comments made by the City of Doral Police Department.
- 2. Applicant shall secure all required permits and inspections prior to the event, as required by the City of Doral Building Department.
- Applicant shall comply with the comments made by the City of Doral Parks and Recreation Department.

- 4. Applicant shall provide a parking agreement and final approval from Codina Partners, or their designee for the usage of the parking field for general event parking located at 8300 NW 53<sup>rd</sup> Street.
- 5. Applicant shall provide a site map illustrating the parking field that will be utilized for valet services.
- 6. Applicant shall secure all required license(s) prior to the event, as required by the City of Doral Planning & Zoning Department's Occupational Licensing Division.
- 7. Applicant shall provide to the Planning and Zoning Department an adequate certificate of insurance prior to the event.

<u>Section 3.</u> <u>Effective Date.</u> This Resolution shall take effect immediately upon adoption.
