FIRST AMENDMENT TO THE AGREEMENT BETWEEN THE CITY OF DORAL AND SFM SERVICES, INC. FOR RIGHT-OF-WAY MAINTENANCE SERVICES

This First Amendment to the Agreement between the CITY OF DORAL ("City") and SFM SERVICES INC. ("Provider") executed this <u>24</u> day of July, 2023, is made a part of the original Agreement between the parties dated August 31, 2020 (the "Agreement"), between the City and Provider attached hereto as Exhibit "A". The City and Provider hereby agree as follows:

RECITALS

WHEREAS, the City issued and awarded Invitation to Bid (ITB) #2020-14 to Provider to provide Right-of-Way Maintenance Services ("Services") for a period of three (3) years with the option to renew for an additional two (2) one-year (1) periods; and

WHEREAS, pursuant to Resolution No. 20-159, the City approved the aforementioned award and resulting Agreement for said Services; and

WHEREAS, the Agreement became effective upon full execution, which date was August 31, 2020, however, the term of the Agreement did not specifically provide for the two (2) one-year (1) renewal terms set forth in the ITB and award; and

WHEREAS, on October 1, 2020, the City issued a Notice to Proceed to the Provider to commence the Services under the Agreement; and

WHEREAS, the City being satisfied with the Services provided by the Provider, the City and Provider now wish to amend the original agreement through this First Amendment to provide for the originally contemplated renewal terms, and to exercise the same.

NOW THEREFORE, in consideration of the promises and the mutual covenants herein, the parties agree as follows:

- EFFECTIVE DATE. The effective date of this First Amendment shall be August 30, 2023.
- 2. <u>AMENDING TERM.</u> Section 2.1 "TERM/COMMENCEMENT DATE", is hereby deleted in its entirety, and substituted with the following language:
 - 2.1 This initial Agreement shall become effective on August 31, 2020, and shall remain in effect for an initial three (3) year term, unless earlier terminated in accordance with Paragraph 8. Prior to, or upon completion of

the initial term, the City shall have the option to renew this Agre ment for two (2) additional one (1) year periods. The Provider shall maintain, for the entirety of the stated additional periods(s), the same terms and conditions included within this original Agreement. Continuation of the Agreement beyond the initial term, and the optional years, is a City prerogative, and not a right of the Provider.

Except as modified herein, all other terms and conditions of Sect on 2 of the original Agreement shall remain in full force and effect.

- 3. <u>EXTENSION OF TERM.</u> The parties hereby agree to renew the Agree nent for one (1) year as of the Effective Date of this First Amendment, thereby exercising its first of two renewal options.
- 4. <u>OTHER PROVISIONS REMAIN IN EFFECT.</u> Except as specifically mod fied herein, all terms and conditions of the original Agreement between the parties shall remain in full force and effect.
- 5. <u>CONFLICTING PROVISIONS.</u> The terms, statements, requirements, and provisions contained in this First Amendment shall prevail and be given superior effect and priority over any conflicting or inconsistent term, statement, requirement or provision contained in any other document or attachment, including but not limited to Exhibit "A".

WHEREAS, the City of Doral Public Works Department (PWD) provides exceptional services to ensure that the City of Doral continues to follow the "Keep Doral Beautiful" initiative; and

WHEREAS, to provide excellent service to the residents and business owners of Doral, the Right-of-Way Maintenance Program was created in 2007; and

WHEREAS, this maintenance program includes for maintenance to be performed within the City's public right-of-way green areas that includes swales, medians, and canal right-of-way; and

WHEREAS, right-of-way services also include the repairs of irrigation throughout the City and the purchase of planting materials within this contract; and

WHEREAS, the current right-of-way maintenance contract is set to expire on October 1, 2020 or sooner; and

WHEREAS, on April 23, 2020, the City of Doral issued Invitation to Bid #2020-14

"Right-of-Way Maintenance Services" (the ITB) to competitively advertise the right-of-way

services; and

WHEREAS, the City requested for all submitters to consider the bid amount for a

potential five (5) year contract; and

WHEREAS, the City received five (5) submittals in response to the ITB which were

opened on May 21, 2020 at 11:00 a.m. At the time of recommendation, it was determined

that only three (3) firms meet the required criteria; and

WHEREAS, upon review of the bids submitted, City Staff respectfully requests that

the Mayor and the City Council-Members authorize the City Manager to enter into an

agreement with SFM Services, Inc. who was deemed the lowest most responsive and

responsible bidder for the provision of right-of-way maintenance services, for a three (3)

year period with the option to renew for an additional two (2) one-year (1) periods under

the same terms, conditions, and contract prices, in an amount not to exceed approved

budgeted funds; and

WHEREAS, funding for this request is available in the current Fiscal Year from the

Public Works General Fund – "Contractual Services Account" (Account No.

001.80005.500340), and from the Public Works Stormwater Fund "Contractual Services

Account" (Account No. 401.80005.500340).

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY
