

RESOLUTION No. 16-59

A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, APPROVING A BUDGET TRANSFER AND REQUEST FOR POLICE EXTRA DUTY FUNDS; AUTHORIZING THE CITY MANAGER TO EXPEND UP TO \$126,500.00 FOR THE PROVISION OF POLICE EXPENSES FOR THE WORLD CHAMPIONSHIP GOLF TOURNAMENT; PROVIDING FOR IMPLEMENTATION; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, in January of 2016, the City Council for the City of Doral (the "City") approved, in part, via Resolution 16-17, a sponsorship proposal from the Professional Golf Association for the Cadillac World Golf Championship Tournament to be hosted in the City of Doral from March 2 through 6, 2016 (the "Tournament"); and

WHEREAS, that sponsorship included, in part, the provision of certain in-kind contribution from the City in the form of Police services; and

WHEREAS, the City's approved and adopted 2015-2016 Fiscal Year Budget did not provide fully fund the expenses associated with the provision of the in-kind Police service ; and

WHEREAS, it has been determined that the cost for extra duty police services to staff the Tournament will be \$126,500.00; and

WHEREAS, Staff has recommend requests the Mayor and City Council authorize a transfer from Capital Outlay 001.60005.500640 to the Police Department Off-Duty account 001.60005.500150 and authorize the City Manager to expend up to \$126,500.00, to cover extra duty police services.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AS FOLLOWS:

Section 1. Recitals. The above recitals are confirmed, adopted, and incorporated herein and made a part hereof by this reference.

Section 2. Approval. A transfer from Capital Outlay account (001.60005.500640) to the Police Department Off-Duty account (001.60005.500150) in the amount of \$126,500.00 is hereby approved.

Section 3. Authorization. The City Manager is authorized to transfer the funds as specified herein for the provision of the in-kind Police services for the Tournament.

Section 4. Implementation. The City Manager and the City Attorney are hereby authorized to take such further action as may be necessary to implement the purpose and provisions of this Resolution.


Section 5. Effective Date. This Resolution shall become effective immediately upon its adoption.
