A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA URGING THE MIAMI-DADE COUNTY BOARD COUNTY COMMISSIONERS TO **AUTHORIZE** RENAMING OF NW 107TH AVENUE TO PERRY ELLIS AVENUE: AUTHORIZING THE CITY CLERK TO TRANSMIT THIS RESOLUTION TO COMMISSIONER JOSE "PEPE" DIAZ IN ORDER TO SPONSOR THIS REQUEST FOR RENAMING BEFORE THE MIAMI-DADE COUNTY BOARD OF COUNTY COMMISSIONERS FOR CONSIDERATION AT ITS REGULARLY **SCHEDULED MEETING: PROVIDING EFFECTIVE DATE**

WHEREAS, Perry Ellis International, one of the City of Doral's largest employers, has been operating its facility located on NW 107th Avenue in the City of Doral since 1997; and

WHEREAS, Perry Ellis International is one of the most highly regarded and honored companies in the Miami-Dade County area and has been ranked as one of the top 100 largest public companies in Florida by the Miami Herald; and

WHEREAS, the City of Doral desires to rename NW 107th Avenue between N.W. 41st Street and N.W. 25th Street as "Perry Ellis Way;" and

WHEREAS, Rule 9.02 of Section 2-1 of the Miami-Dade County Code authorizes the renaming of County roads in order to honor an individual who has made a direct, significant contribution to the community;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA THAT:

<u>Section 1</u>. The foregoing "WHEREAS" clauses are hereby ratified and confirmed as being true and correct and are hereby made a part of this Resolution upon adoption hereof.

<u>Section 2.</u> The City hereby urges the Miami-Dade County Board of County Commissioners to authorize the renaming of NW 107th Avenue between N.W. 41st Street and N.W. 25th Street to "Perry Ellis Way."

<u>Section 3.</u> The City Clerk is hereby authorized and directed to transmit this Resolution to Commissioner Jose "Pepe" Diaz in order to sponsor this request for renaming before the Miami-Dade County Board of County Commissioners for consideration at its next regularly scheduled meeting.

<u>Section 4.</u> This resolution shall become effective upon its passage and adoption by the City Council.

WHEREAS, Council unanimously resolved to approve a resolution urging the Miami-Dade County Board of County Commissioners to rename a portion of N.W. 107th Avenue between N.W. 41st Street and N.W. 25th Street as "Perry Ellis Way."
