

RESOLUTION No. 24-17

**A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF
THE CITY OF DORAL, FLORIDA, APPOINTING FRANCISCO RIOS
AS INTERIM CITY MANAGER; AND PROVIDING FOR AN
EFFECTIVE DATE**

WHEREAS, the Mayor and City Council has an immediate need for Interim City Manager services to assist in implementing municipal government in the City of Doral (the “City”); and

WHEREAS, the City Council desires to appoint Francisco Rios as Interim City Manager subject to certain terms and conditions; and

WHEREAS, it is in the best interest of the City that the Council appoint Francisco Rios as Interim City Manager.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AS FOLLOWS:

Section 1. Recitals. The above recitals are confirmed, adopted, and incorporated herein and made part hereof by this reference.

Section 2. Appointment of Interim City Manager. Francisco Rios is hereby appointed as Interim City Manager for the City of Doral until such time as a replacement City Manager is appointed. As a condition of accepting said appointment, the City Council agreed that during his tenure as Interim City Manager, Francisco Rios shall have the same protections as that provided under the former City Manager’s Agreement as it relates to just and reasonable cause, along with any other benefits as stated in the former City Manager’s Agreement. Upon the appointment of a replacement City Manager, Mr. Rios will return to and resume his previous position as the Deputy City Manager. Upon Mr. Rios resuming his previous position as the Deputy City Manager there shall be a 90-day

transition period within which no action can be taken against Mr. Rios without just and reasonable cause.

Section 3. Effective Date. This Resolution shall take effect immediately upon adoption.

The Prime Sponsor of the foregoing resolution is Councilwoman Digna Cabral.

The foregoing Resolution was offered by Councilmember Porrás who moved its adoption.

The motion was seconded by Vice Mayor Puig-Corve and upon being put to a vote, the vote was as follows:


