A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AUTHORIZING THE ADOPTION OF THE PFM FINANCIAL ADVISORS, LLC AGREEMENT VIA THE CITY OF FT. LAUDERDALE REQUEST FOR PROPOSALS #12184-695 TO PROVIDE FINANCIAL ADVISORY SERVICES; PROVIDING FOR IMPLEMENTATION; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, the City of Doral (the "City") seeks to adopt the City of Ft. Lauderdale agreement with PFM Financial Advisors, LLC for financial advisory services;

WHEREAS, section 2-322 of the City Code of Ordinances provides that the City may enter into contracts competitively entered by other governmental entities; and

WHEREAS, staff respectfully requests that the City Council authorize the City Manager to adopt the City of Ft. Lauderdale agreement, which was competitively entered into in a manner like that set forth in Chapter 2, Article V, of the City's Code of Ordinance, for financial advisory services, and authorize the City Manager to expend budgeted funds in an amount not to exceed budgeted funds, for the period set forth in the City of Ft. Lauderdale agreement, and any approved additional subsequent extension; and

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DORAL AS FOLLOWS:

<u>Section 1.</u> Recitals. The above recitals are confirmed, adopted, and incorporated herein and made a part hereof by this reference.

<u>Section 2.</u> <u>Authorization.</u> The City Council hereby authorizes the City Manager to adopt the City of Ft. Lauderdale agreement with PFM Financial Advisors, LLC for financial advisory services, and authorize the City Manager to expend budgeted funds in an amount not to exceed budgeted funds.
