A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, APPROVING A BUDGET TRANSFER IN THE AMOUNT OF \$28,350.00 FROM ACCOUNT 001.50005.500492 TO THE PUBLIC AFFAIRS DIVISION AND GENERAL FUND EXPENSE ACCOUNTS FOR THE GENERAL OBLIGATION (G.O.) PARKS BOND EDUCATIONAL CAMPAIGN; PROVIDING FOR IMPLEMENTATION; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, During the June 13, 2018 Council Meeting, the City Council for the City of Doral (the "City") unanimously approved a Parks Bond Referendum to build and improve park facilities and recreational amenities. The referendum will be on the November 6, 2018 ballot asking voters to authorize the general obligation bond that would fund \$150 million in capital park projects; and

WHEREAS, the City will be deploy an educational campaign consisting of multiple outreach efforts including: direct mailers, brochures, bus benches, newspaper ads, workshops, etc. for the purpose of transparency with our residents and to provide all pertinent information for a clear understanding of the G.O. Parks Bond when they vote; and

WHEREAS, while funds needed to carry out this educational campaign are in the FY 17-18 budget, they are not in the specific accounts for the Public Affairs Division to utilize; and

**WHEREAS**, staff recommends approval to transfer funds allocated for this campaign under the 001.50005.500492 account to the Public Affairs Division and General Fund expense accounts in the amount of \$28,350.00.
