a. There were no comments made during public comments.

5. Approval of Minutes

Motion to approve the July 19, 2018 meeting minutes as presented made by Alejandra Moreno and seconded by Elizabeth Nieves Board Member. By consensus, motion passes unanimously.

6. Discussion Items

a. Discussion: Presentation - The Women's Fund Miami-Dade

Allie L. Martinez, Director for The Women's Fund Miami-Dade who has a background in Clinical Data & Research, attended to report status of County Report – where we stand as a County in Equal Pay and analyzed Public & Private perspective.

She shared an overview of re-organization. The new Executive Director has a wonderful vision for The Women's Fund Miami-Dade. Collectively they re-designed a new Logo: W and adopted a new Motto: Women Strong World Strong

Thus far they have implemented a comprehensive plan, involving monthly campaigns and hold a Forum, first Thursday of every month. For example, October is Domestic Violence Month and will be the first forum topic.

In addition, their website was completely revamped (womensfundmiami.org), now having Launch Take-Action, social media and digital marketing campaigns. Resource page launched Resources Hub for Domestic Violence and will soon expand to include tools, support, online presentations, online training, best practices seminars, user generated forum and expert webinars.

They also created a list of the following 4 Pillars under which organizations and individuals can find links to various services on their website:

Economic Mobility

Leadership

Freedom from Violence

Health & Wellbeing

April 19th – National Equal Pay Day – Miami Dade

The Women's Fund is developing a forum (businesses) to participate.

Their objective to develop more advocacy putting together people & organizations to drive consumers forward. Organizations can sign up to join Equal Pay Movement, which provide guides and resources on how to go about in achieving Pay Equality adopting the assistance of Equal Pay Ambassadors.

It is interesting to note that Hispanic women are paid on average \$0.50 less on the dollar.

As part of the comprehensive plan they are developing synergies with Doral Chamber of Commerce, to engage them to get business owners to participate. The presentation was concluded where Allie Martinez asked for collaboration in promoting their cause and we would cross promote our causes, developing mutual goals to move forward.

b. Discussion: Advisory Board to organize "Women's Equality Day" event for City of Doral and request approval to make this a yearly event

Advisory Board wishes to organize a Women's Equality Day event, at no cost, on Saturday October 20th or Saturday October 27th from 10:00 am – 1:00 pm, during October which is known for Domestic Violence Awareness month.

Alejandra Moreno made a motion to present to Council for approval, second by Elizabeth Nieves and unanimous approval. Next Council Meeting will be held September 12th at 6:00 pm. October 20th of which Advisory Board will be attending.

Pending approval, the logistics and additional sponsors will be coordinated. For now, Realty World South Florida will be catering the event and Women's Fund — Miami-Dade will be hosting an exhibitor table. Approval to partnership with Women's Fund will be requested from Council in which we would sign a collaboration agreement, which they will provide a template to Advisory Board.

In preparation for this event, Advisory Board requested from Lisandra to ask Licensing Clerk's office and Planning & Zoning Department to provide statistics on how many businesses are owned by women.

c. Discussion: Postpone City of Doral Sexual Harassment Training

Alejandra Moreno made a motion to postpone City of Doral Sexual Harassment Training to after the new year, second by Elizabeth Nieves and unanimous approval.

d. Discussion: Nominate candidate for Florida's Spirit of Community Award

Alejandra Moreno made a motion to nominate Barbara Romani as a candidate for Florida's Spirit of Community Award, recognizing her as a long-time resident of Doral, 50 years at Citibank, and was a dynamic member of "WE WILL REBUILD" after Hurricane Andrew.
