In the event that any terms or conditions of this Work Order conflict with the Continuing Services Agreement, the provisions of this specific Work Order shall prevail and apply.

Work Order is not binding until the City of Doral agrees and approves this Work Order.

WHEREAS, the City of Doral Public Works Department wishes to secure a firm to provide Construction Engineering Inspection ("CEI") services for the construction of stormwater improvements at Sub Basin D-3 which is located at NW 29 St. between NW 82 Ave. and NW 79 Ave. and at NW 31 St. between NW 82 Ave. and NW 79 Ave. (the "Project"); and

WHEREAS, R.J. Behar & Company, Inc. (RJ Behar) developed the design plans and obtained all necessary permits and approvals for the project to move forward into construction; and

WHEREAS, RJ Behar is a pre-qualified provider of professional engineering services selected in accordance with Consultant Competitive Negotiation Act requirements and approved by the City Council in December 2014; and
