A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, APPROVING AN OUTDOOR EVENT PERMIT FOR THE CODINA PARTNERS, LLC. - 3. Applicant shall comply with acquiring MOT permit, given by the City of Doral Public Works Department.
- 4. Applicant shall provide an adequate certificate of insurance prior to the event start date.
