## WORK ORDER No. 4 RFQ 2022- 13 Milling, Resurfacing, and Striping Construction Services

The City of Doral authorizes the firm of Weekley Asphalt Paving, Inc. to proceed with the provision of Construction Services for Miscellaneous Repairs at the intersection of (1) NW 53<sup>rd</sup> Street & NW 79<sup>th</sup> Avenue and (2) along NW 112<sup>th</sup> Avenue north of NW 43<sup>rd</sup> Lane. Where Weekley Asphalt Paving, Inc. is a pre-qualified provider of Construction Services selected in accordance with RFQ 2022-13 requirements and approved by the City Council on August 9, 2022, through Resolution 22-145. The work should be performed in accordance with the contract provisions contained in the Construction Services Agreement between Weekley Asphalt Paving, Inc. and the City of Doral dated August 9, 2022, and the attached Proposal submitted on January 3, 2023, submitted by your firm for the above referenced project.

## SCOPE OF SERVICES AND SCEHDULE:

The scope of the project will be as described in the attached proposal from Weekley Asphalt Paving, Inc. submitted on January 3, 2023. The schedule requires the work to be performed within 30 calendar days from NTP. All limitations of time set forth in this Work Order are of the essence. The performance of services associated with this Work Order will be executed based on the schedule of values submitted by Weekley Asphalt Paving, Inc., with a not to exceed amount of \$47,223.33, which includes a 10% contingency amount for any unforeseen conditions.

You are required by the Continuing Construction Agreement to begin work subsequent to the execution of this Work Order, or as directed otherwise. If you fail to begin work subsequent to the execution of this Work Order, the City of Doral will be entitled to disqualify the Proposal and revoke the award. Work Order incorporates the terms and conditions set forth in the Continuing Construction Agreement dated August 9, 2022, between the parties as though fully set forth herein. In the event that any terms or conditions of this Work Order conflict with the Continuing Construction Agreement, the provisions of this specific Work Order shall prevail and apply.

This Work Order is not binding until the City of Doral agrees and approves this Work Order.

## **RESOLUTION No. 23-22**

A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, APPROVING A WORK ORDER WITH WEEKLEY ASPHALT PAVING, INC. FOR THE PROVISION OF ROADWAY RESTORATION AND STRIPING AT THE INTERSECTION OF NW 53 STREET AND NW 79 AVENUE, AND ALONG NW 112 AVENUE NORTH OF NW 43 LANE, IN AN AMOUNT NOT TO EXCEED \$47,223.33 WHICH INCLUDES A 10% CONTINGENCY FOR ANY UNFORSEEN CIRCUMSTANCES; RECOGNIZING THAT WEEKLEY ASPHALT PAVING, INC. IS A CITY OF DORAL PRE-QUALIFIED VENDOR; AUTHORIZING THE CITY MANAGER TO EXECUTE THE WORK ORDER AND EXPEND BUDGETED FUNDS ON BEHALF OF THE CITY; PROVIDING FOR IMPLEMENTATION; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, on June 14, 2022, the existing contract for "Milling, Resurfacing and Miscellaneous Stormwater and Roadway Improvement" (ITB-2019-12) expired; and

WHEREAS, the Public Works Department (PWD) proceeded to fragment the allencompassing scope of work of previous contract to its new format of three (3) "scope specific" areas of construction; and

WHEREAS, on April 21, 2022, Request for Qualification (RFQ) No. 2022-13 "Milling, Resurfacing, and Striping Construction Services" was issued and advertised on the City's Website; and

WHEREAS, a recommendation was made by the committee to award the top four (4) ranked firms, H&J Asphalt, Inc., H&R Paving, Inc., Weekley Asphalt Paving, Inc., and General Asphalt, establishing a Pool of Construction Firms for "Milling, Resurfacing, and Striping Construction Services"; and

WHEREAS, the PWD needs to secure a firm to provide roadway restoration and striping at the intersection of NW 53<sup>rd</sup> Street and NW 79<sup>th</sup> Avenue, and along NW 112<sup>th</sup> Avenue north of NW 43<sup>rd</sup> Lane; and

WHEREAS, the PWD requested a proposal from the pre-qualified pool of contractors for "Milling, Resurfacing, and Striping Construction Services"; and

WHEREAS, Weekley Asphalt Paving, Inc., provided attached proposal and was deemed the lowest bid proposal with a not to exceed amount of \$47,223.33 which includes a 10% contingency for any unforeseen.; and

WHEREAS, the contract between Weekley Asphalt Paving, Inc. and the City of Doral was procured through the publicly advertised Request for Qualification (RFQ) 2022-13 process to select a pool of pre-qualified Construction Services firms for "Milling, Resurfacing, and Striping Construction Services" projects; and

WHEREAS, this group of four (4) firms was approved by the City Council during the August 2022 Council meeting via Resolution No. 22-144; and

WHEREAS, City staff respectfully requests that the Mayor and the City Councilmembers approve Work Order No. 4 for Weekley Asphalt Paving, Inc., a copy of which is attached hereto as Exhibit "A", for the provision of roadway restoration and striping at the intersection of NW 53<sup>rd</sup> Street and NW 79<sup>th</sup> Avenue, and along NW 112<sup>th</sup> Avenue north of NW 43<sup>rd</sup> Lane in an amount not to exceed \$47,223.33; which includes a 10% contingency for any unforeseen; and

WHEREAS, funding for this request is available in the Public Works CITT Fund – "Improvements Street" Account, Account Num. 106.80005.500633.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL AS FOLLOWS:

<u>Section 1.</u> <u>Recitals.</u> The above recitals are confirmed, adopted, and incorporated herein and made part hereof by this reference.

Section 2. Approval. Work Order No. 4 to Weekley Asphalt Paving, Inc. for roadway restoration and striping at the intersection of NW 53<sup>rd</sup> Street and NW 79<sup>th</sup> Avenue, and along NW 112<sup>th</sup> Avenue north of NW 43<sup>rd</sup> Lane in an amount not to exceed \$47,223.33; which includes a 10% contingency for any unforeseen, a copy of which is attached hereto as Exhibit "A", together with such non-material changes as may be acceptable to the City Manager and approved as to form and legality by the Interim City Attorney, is hereby approved.

<u>Section 3.</u> <u>Authorization.</u> The City Manager is authorized to execute the work order and expend budgeted funds on behalf of the City.

<u>Section 4.</u> <u>Implementation.</u> The City Manager and the Interim City Attorney are hereby authorized to take such further action as may be necessary to implement the purpose and the provisions of this Resolution.
