

RESOLUTION No. 23-102

A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, APPROVING THE AWARD OF FISCAL YEAR 2023 CYCLE COMMUNITY BASED ORGANIZATION GRANTS IN THE AMOUNT OF \$4,500.00 TO DUE TO ARTS INC.; \$4,500.00 TO EVERLASTING DANCE FOUNDATION; \$3,500.00 TO PERLA DE ESPERANZA; \$3,900.00 TO SUNSHINE INTERNATIONAL INSTITUTE; AND \$4,500.00 TO VET INFO INC.; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, the City of Doral (“City”) received five (5) eligible applications in response to the FY2023 Cycle of Community Based Organization (“CBO”) Grant Applications by March 10th, 2023; and

WHEREAS, after careful review of the applications, and applying the applicable scoring criteria, the CBO Evaluation Committee respectfully recommends that the Mayor and City Council approve CBO Grant awards to each of the following organizations:

1. Due To Arts, Inc. - \$4,500.00
2. Everlasting Dance Foundation - \$4,500.00
3. Perla de Esperanza - \$3,500.00
4. Sunshine International Institute - \$3,900.00
5. Vet Info Inc. - \$4,500.00

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AS FOLLOWS:

Section 1. Recitals. The above recitals are confirmed, adopted, and incorporated herein and made as part hereof by this reference.

Section 2. Approval. The Mayor and the City Council of the City of Doral hereby approve a CBO award of \$4,500.00 to Due To Arts Inc., \$4,500.00 to Everlasting Dance

Foundation, \$3,500.00 to Perla de Esperanza, \$3,900.00 to Sunshine International Institute, and \$4,500.00 to Vet Info Inc.

Section 3. Effective Date. This Resolution shall become effective immediately upon its adoption.


