

RESOLUTION No. 13-86

A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF DORAL, FLORIDA IN SUPPORT OF THE MIAMI-DADE COMMISSION ON ETHICS AND PUBLIC TRUST'S "ETHICAL GOVERNANCE DAY 2013" TO BE HELD ON TUESDAY, OCTOBER 22, 2013; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, the Miami-Dade Commission on Ethics and Public Trust (Commission) has been established to ensure the integrity of local governments and elections, to restore public confidence in government and to serve as guardian of the public trust; and

WHEREAS, the Commission is committed to educating the public and all local elected officials and public employees in ethical governance practices; and

WHEREAS, the Commission has historically included, as part of its mission, community outreach programs to schools, businesses, and civic institutions; and

WHEREAS, the first step toward the promotion of a more ethical government requires encouragement of greater civic involvement in government, as well as a stronger commitment to public and community service by citizens of all ages, and

WHEREAS, the Commission initiated the concept of sponsoring an annual "Ethical Governance Day" during 2012, which event was carried out successfully with the cooperation of many other agencies and individuals; and

WHEREAS, the Commission has proclaimed Tuesday, October 22, 2013 as "Ethical Governance Day 2013" in Miami-Dade County and calls upon all public and private institutes and residents of the City to participate in appropriate civic and

education programs on that day to underscore the sacred trust placed upon all of us by this nation's heritage.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA AS FOLLOWS:

Section 1. The above recitals are true and correct and incorporated herein by this reference.

Section 2. The City of Council of the City of Doral hereby supports the Miami-Dade Commission on Ethics and Public Trust's "Ethical Governance Day" on Tuesday, October 22, 2013, and encourages it's elected officials as well as all citizens within the City and the County to participate in the events of this day in order to create greater civic involvement and promote a stronger commitment to public and community service.

Section 4. This Resolution shall become effective immediately upon its adoption.




